## 20 Interpretation of Chapter

In this Chapter—

"enactment" includes an enactment contained in a local Act or comprised in subordinate legislation (within the meaning of the Interpretation Act 1978);

[F1":EPB" means an economic prosperity board established under section 88 of the Local Democracy, Economic Development and Construction Act 2009;]

"Minister of the Crown" has the same meaning as in the Ministers of the Crown Act 1975;

"local public function", in relation to a permitted authority, means a public function in so far as it relates to—

- (a) the permitted authority's area, or
- (b) persons living, working or carrying on activities in that area; "permitted authority" means—
- (a) a county council in England,
- (b)
- (c) a district council,

(d) a combined authority established under section 103 of that Act;
