

Legal Aid, Sentencing and Punishment of Offenders Act 2012

2012 CHAPTER 10

U.K.

An Act to make provision about legal aid; to make further provision about funding legal services; to make provision about costs and other amounts awarded in civil and criminal proceedings; to make provision about referral fees in connection with the provision of legal services; to make provision about sentencing offenders, including provision about release on licence or otherwise; to make provision about the collection of fines and other sums; to make provision about bail and about remand otherwise than on bail; to make provision about the employment, payment and transfer of persons detained in prisons and other institutions; to make provision about penalty notices for disorderly behaviour and cautions; to make provision about the rehabilitation of offenders; to create new offences of threatening with a weapon in public or on school premises and of causing serious injury by dangerous driving; to create a new offence relating to squatting; to increase penalties for offences relating to scrap metal dealing and to create a new offence relating to payment for scrap metal; and to amend section 76 of the Criminal Justice and Immigration Act 2008.

Provision of legal aid

1 Lord Chancellor's functions E+W

- (1) The Lord Chancellor must secure that legal aid is made available in accordance with this Part.
- (2) In this Part "legal aid" means—
 - (a) civil legal services required to be made available under section 9 or 10 or paragraph 3 of Schedule 3 (civil legal aid), and
 - (b) services consisting of advice, assistance and representation required to be made available under section 13, 15 or 16 or paragraph 4 or 5 of Schedule 3 (criminal legal aid).
- (3) The Lord Chancellor may secure the provision of—
 - (a) general information about the law and the legal system, and
 - (b) information about the availability of advice about, and assistance in connection with, the law and the legal system.
- (4) The Lord Chancellor may do anything which is calculated to facilitate, or is incidental or conducive to, the carrying out of the Lord Chancellor's functions under this Part.
- (5) Nothing in this Part affects the powers that the Lord Chancellor has otherwise than under this Part.

2 Arrangements E+W

- (1) The Lord Chancellor may make such arrangements as the Lord Chancellor considers appropriate for the purposes of carrying out the Lord Chancellor's functions under this Part.
- (2) The Lord Chancellor may, in particular, make arrangements by—
 - (a) making grants or loans to enable persons to provide services or facilitate the provision of services,
 - (b) making grants or loans to individuals to enable them to obtain services, and
 - (c) establishing and maintaining a body to provide services or facilitate the provision of services.
- (3) The Lord Chancellor may by regulations make provision about the payment of remuneration by the Lord Chancellor to persons who provide services under arrangements made for the purposes of this Part.

- (4) If the Lord Chancellor makes arrangements for the purposes of this Part that provide for a court, tribunal or other person to assess remuneration payable by the Lord Chancellor, the court, tribunal or person must assess the remuneration in accordance with the arrangements and, if relevant, with regulations under subsection (3).
- (5) The Lord Chancellor may make different arrangements, in particular, in relation to—
 - (a) different areas in England and Wales,
 - (b) different descriptions of case, and
 - (c) different classes of person.

3 Standards of service E+W

- (1) The Lord Chancellor may set and monitor standards in relation to services made available under this Part.
- (2) The Lord Chancellor may, in particular, make arrangements for the accreditation of persons providing, or wishing to provide, such services by—
 - (a) the Lord Chancellor, or
 - (b) persons authorised by the Lord Chancellor.
- (3) Arrangements for accreditation must include—
 - (a) arrangements for monitoring services provided by accredited persons, and
 - (b) arrangements for withdrawing accreditation where the services provided are unsatisfactory.
- (4) The Lord Chancellor may impose charges in connection with—
 - (a) accreditation,
 - (b) monitoring services provided by accredited persons, and
 - (c) authorising accreditation by others.
- (5) Persons authorised by the Lord Chancellor may, in accordance with the terms of their authorisation, impose charges in connection with—
 - (a) accreditation, and
 - (b) monitoring services provided by accredited persons.

4 Director of Legal Aid Casework E+W

- (1) The Lord Chancellor must designate a civil servant as the Director of Legal Aid Casework ("the Director").
- (2) The Lord Chancellor must make arrangements for the provision to the Director by civil servants or other persons (or both) of such assistance as the Lord Chancellor considers appropriate.
- (3) The Director must—
 - (a) comply with directions given by the Lord Chancellor about the carrying out of the Director's functions under this Part, and
 - (b) have regard to guidance given by the Lord Chancellor about the carrying out of those functions.

- (4) But the Lord Chancellor—
 - (a) must not give a direction or guidance about the carrying out of those functions in relation to an individual case, and
 - (b) must ensure that the Director acts independently of the Lord Chancellor when applying a direction or guidance under subsection (3) in relation to an individual case.
- (5) The Lord Chancellor must publish any directions and guidance given under this section.
- (6) Directions and guidance under this section may be revised or withdrawn from time to time.

5 Delegation E+W

- (1) The following functions of the Lord Chancellor may be exercised by, or by employees of, a person authorised by the Lord Chancellor for that purpose—
 - (a) securing the provision of information under section 1(3), and
 - (b) setting and monitoring standards under section 3.
- (2) Regulations may provide for a function of the Lord Chancellor under regulations made under this Part to be exercisable by, or by employees of, a person authorised by the Lord Chancellor for that purpose.
- (3) The functions conferred on the Director by this Part may be exercised by, or by employees of, a person authorised by the Director for that purpose.
- (4) Regulations may provide for a function of the Director under regulations made under this Part to be exercisable by, or by employees of, a person authorised by the Director for that purpose.
- (5) A direction given by the Lord Chancellor under section 4 about the carrying out of the Director's functions may, in particular, require the Director—
 - (a) to authorise, or not to authorise, a person to carry out a function specified in the direction, or
 - (b) to authorise, or not to authorise, a person specified, or of a description specified, in the direction to carry out such a function.
- (6) Regulations under subsection (2) or (4) may provide that a function may be exercised—
 - (a) wholly or to a limited extent;
 - (b) generally or in particular cases or areas;
 - (c) unconditionally or subject to conditions.
- (7) An authorisation given for the purposes of this section or regulations under this section may provide that a function may be exercised—
 - (a) wholly or to a limited extent;
 - (b) generally or in particular cases or areas;
 - (c) unconditionally or subject to conditions.
- (8) In the case of an authorisation given for the purposes of regulations under this section, subsection (7) is subject to the provisions of the regulations.

6 Authorisations E+W

- (1) An authorisation given for the purposes of section 5 or regulations under that section—
 - (a) may specify its duration,
 - (b) may specify or describe the authorised person,
 - (c) may be varied or revoked at any time by the person who gave it, and
 - (d) does not prevent the Lord Chancellor, the Director or another person from exercising the function to which the authorisation relates.
- (2) Anything done or omitted to be done by or in relation to a person authorised under section 5(1) or regulations under section 5(2) (or an employee of such a person) in, or in connection with, the exercise or purported exercise of the function concerned is to be treated for all purposes as done or omitted to be done by the Lord Chancellor.
- (3) Anything done or omitted to be done by or in relation to a person authorised under section 5(3) or regulations under section 5(4) (or an employee of such a person) in, or in connection with, the exercise or purported exercise of the function concerned is to be treated for all purposes as done or omitted to be done by the Director.
- (4) Subsections (2) and (3)—
 - (a) do not affect the rights and liabilities of the authorised person or the Lord Chancellor under any arrangements made between them,
 - (b) do not prevent any civil proceedings which could otherwise be brought by or against the authorised person (or an employee of that person) from being brought,
 - (c) do not apply for the purposes of criminal proceedings brought in respect of anything done or omitted to be done by the authorised person (or an employee of that person), and
 - (d) do not make the Lord Chancellor or the Director liable under section 6 of the Human Rights Act 1998 in respect of any act or omission of an authorised person if the act or omission is of a private nature.

(5) Where—

- (a) an authorisation given for the purposes of section 5 or regulations under that section is revoked, and
- (b) at the time of the revocation so much of any contract made between the authorised person and the Lord Chancellor as relates to the exercise of the function is subsisting,

the authorised person is entitled to treat the contract as repudiated by the Lord Chancellor (and not as frustrated by reason of the revocation).

(6) In this section "authorised person" means a person authorised for the purposes of section 5 or regulations under that section.

7 Annual report E+W

- (1) As soon as reasonably practicable after the end of each financial year, the Director must prepare an annual report for the financial year.
- (2) The annual report must state how the Director has carried out the functions of the office in the financial year.

- (3) The Director must send a copy of the report to the Lord Chancellor.
- (4) The Lord Chancellor must—
 - (a) lay the copy of the report before Parliament, and
 - (b) arrange for it to be published.
- (5) In this section "financial year" means—
 - (a) the period beginning on the day on which section 4 comes into force and ending on the following 31 March, and
 - (b) each successive period of 12 months.

Civil legal aid

8 Civil legal services E+W

- (1) In this Part "legal services" means the following types of services—
 - (a) providing advice as to how the law applies in particular circumstances,
 - (b) providing advice and assistance in relation to legal proceedings,
 - (c) providing other advice and assistance in relation to the prevention of disputes about legal rights or duties ("legal disputes") or the settlement or other resolution of legal disputes, and
 - (d) providing advice and assistance in relation to the enforcement of decisions in legal proceedings or other decisions by which legal disputes are resolved.
- (2) The services described in subsection (1) include, in particular, advice and assistance in the form of—
 - (a) representation, and
 - (b) mediation and other forms of dispute resolution.
- (3) In this Part "civil legal services" means any legal services other than the types of advice, assistance and representation that are required to be made available under sections 13, 15 and 16 (criminal legal aid).

9 General cases E+W

- (1) Civil legal services are to be available to an individual under this Part if—
 - (a) they are civil legal services described in Part 1 of Schedule 1, and
 - (b) the Director has determined that the individual qualifies for the services in accordance with this Part (and has not withdrawn the determination).
- (2) The Lord Chancellor may by order—
 - (a) add services to Part 1 of Schedule 1, or
 - (b) vary or omit services described in that Part,

(whether by modifying that Part or Part 2, 3 or 4 of the Schedule).

10 Exceptional cases E+W

- (1) Civil legal services other than services described in Part 1 of Schedule 1 are to be available to an individual under this Part if subsection (2) or (4) is satisfied.
- (2) This subsection is satisfied where the Director—
 - (a) has made an exceptional case determination in relation to the individual and the services, and
 - (b) has determined that the individual qualifies for the services in accordance with this Part,

(and has not withdrawn either determination).

- (3) For the purposes of subsection (2), an exceptional case determination is a determination—
 - (a) that it is necessary to make the services available to the individual under this Part because failure to do so would be a breach of—
 - (i) the individual's Convention rights (within the meaning of the Human Rights Act 1998), or
 - (ii) any rights of the individual to the provision of legal services that are enforceable EU rights, or
 - (b) that it is appropriate to do so, in the particular circumstances of the case, having regard to any risk that failure to do so would be such a breach.
- (4) This subsection is satisfied where—
 - (a) the services consist of advocacy in proceedings at an inquest under the Coroners Act 1988 into the death of a member of the individual's family,
 - (b) the Director has made a wider public interest determination in relation to the individual and the inquest, and
 - (c) the Director has determined that the individual qualifies for the services in accordance with this Part.

(and neither determination has been withdrawn).

- (5) For the purposes of subsection (4), a wider public interest determination is a determination that, in the particular circumstances of the case, the provision of advocacy under this Part for the individual for the purposes of the inquest is likely to produce significant benefits for a class of person, other than the individual and the members of the individual's family.
- (6) For the purposes of this section an individual is a member of another individual's family if—
 - (a) they are relatives (whether of the full blood or half blood or by marriage or civil partnership),
 - (b) they are cohabitants (as defined in Part 4 of the Family Law Act 1996), or
 - (c) one has parental responsibility for the other.

11 Qualifying for civil legal aid E+W

- (1) The Director must determine whether an individual qualifies under this Part for civil legal services in accordance with—
 - (a) section 21 (financial resources) and regulations under that section, and
 - (b) criteria set out in regulations made under this paragraph.

(2) In setting the criteria, the Lord Chancellor—

- (a) must consider the circumstances in which it is appropriate to make civil legal services available under this Part, and
- (b) must, in particular, consider the extent to which the criteria ought to reflect the factors in subsection (3).

(3) Those factors are—

- (a) the likely cost of providing the services and the benefit which may be obtained by the services being provided,
- (b) the availability of resources to provide the services,
- (c) the appropriateness of applying those resources to provide the services, having regard to present and likely future demands for the provision of civil legal services under this Part,
- (d) the importance for the individual of the matters in relation to which the services would be provided,
- (e) the nature and seriousness of the act, omission, circumstances or other matter in relation to which the services are sought,
- (f) the availability to the individual of services provided other than under this Part and the likelihood of the individual being able to make use of such services,
- (g) if the services are sought by the individual in relation to a dispute, the individual's prospects of success in the dispute,
- (h) the conduct of the individual in connection with services made available under this Part or an application for such services,
- (i) the conduct of the individual in connection with any legal proceedings or other proceedings for resolving disputes about legal rights or duties, and
- (i) the public interest.
- (4) In setting the criteria, the Lord Chancellor must seek to secure that, in cases in which more than one form of civil legal service could be provided for an individual, the individual qualifies under this Part for the form of service which in all the circumstances is the most appropriate having regard to the criteria.
- (5) The criteria must reflect the principle that, in many disputes, mediation and other forms of dispute resolution are more appropriate than legal proceedings.
- (6) Regulations under subsection (1)(b) may provide that no criteria apply in relation to a prescribed description of individual or services.

12 Determinations E+W

- (1) A determination by the Director that an individual qualifies under this Part for civil legal services must specify—
 - (a) the type of services, and
 - (b) the matters in relation to which the services are to be available.
- (2) Regulations may make provision about the making and withdrawal of determinations under sections 9 and 10.
- (3) Regulations under subsection (2) may, in particular, include—

- (a) provision about the form and content of determinations and applications for determinations,
- (b) provision permitting or requiring applications and determinations to be made and withdrawn in writing, by telephone or by other prescribed means,
- (c) provision setting time limits for applications and determinations,
- (d) provision for a determination to be disregarded for the purposes of this Part if made in response to an application that is made otherwise than in accordance with the regulations,
- (e) provision about conditions which must be satisfied by an applicant before a determination is made,
- (f) provision about the circumstances in which a determination may or must be withdrawn,
- (g) provision requiring information and documents to be provided,
- (h) provision requiring individuals who are the subject of a determination to be informed of the reasons for making or withdrawing the determination, and
- (i) provision for giving information to individuals who do not qualify for civil legal services under this Part about alternative ways of obtaining or funding civil legal services.
- (4) The circumstances prescribed under subsection (3)(f) may, in particular, relate to whether the individual who is the subject of the determination has complied with requirements imposed by or under this Part.
- (5) Regulations under subsection (2) must make provision establishing procedures for the review of determinations under sections 9 and 10 and of the withdrawal of such determinations.
- (6) Regulations under subsection (2) may make provision for appeals to a court, tribunal or other person against such determinations and against the withdrawal of such determinations.

Criminal legal aid

13 Advice and assistance for individuals in custody E+W

- (1) Initial advice and initial assistance are to be available under this Part to an individual who is arrested and held in custody at a police station or other premises if the Director has determined that the individual qualifies for such advice and assistance in accordance with this Part (and has not withdrawn the determination).
- (2) The Director must make a determination under this section having regard, in particular, to the interests of justice.
- (3) A determination under this section must specify the type of advice or assistance (or both) to be available under this Part.
- (4) Regulations may make provision about the making and withdrawal of determinations under this section.

- (5) Regulations under subsection (4) may, in particular, include—
 - (a) provision about the form and content of determinations and applications for determinations.
 - (b) provision permitting or requiring applications and determinations to be made and withdrawn in writing, by telephone or by other prescribed means,
 - (c) provision setting time limits for applications and determinations,
 - (d) provision for a determination to be disregarded for the purposes of this Part if made in response to an application that is made otherwise than in accordance with the regulations,
 - (e) provision about conditions which must be satisfied by an applicant before a determination is made,
 - (f) provision about the circumstances in which a determination may or must be withdrawn,
 - (g) provision requiring information and documents to be provided, and
 - (h) provision requiring individuals who are the subject of a determination to be informed of the reasons for making or withdrawing the determination.
- (6) The circumstances prescribed under subsection (5)(f) may, in particular, relate to whether the individual who is the subject of the determination has complied with requirements imposed by or under this Part.
- (7) For the purposes of this section, in relation to an individual who is in custody—

"initial advice" means advice as to how the law in relation to a matter relevant to the individual's arrest applies in particular circumstances and as to the steps that might be taken having regard to how it applies;

"initial assistance" means assistance in taking any of those steps which the individual might reasonably take while in custody, including assistance in the form of advocacy.

(8) The Lord Chancellor may by regulations provide that prescribed advice or assistance is not initial advice or initial assistance for the purposes of this section.

14 Criminal proceedings E+W

In this Part "criminal proceedings" means—

- (a) proceedings before a court for dealing with an individual accused of an offence.
- (b) proceedings before a court for dealing with an individual convicted of an offence, including proceedings in respect of a sentence or order,
- (c) proceedings for dealing with an individual under the Extradition Act 2003,
- (d) proceedings for binding an individual over to keep the peace or to be of good behaviour under section 115 of the Magistrates' Courts Act 1980 and for dealing with an individual who fails to comply with an order under that section,
- (e) proceedings on an appeal brought by an individual under section 44A of the Criminal Appeal Act 1968 (appeal in case of death of appellant),
- (f) proceedings on a reference under section 36 of the Criminal Justice Act 1972 on a point of law following the acquittal of an individual on indictment,

- (g) proceedings for contempt committed, or alleged to have been committed, by an individual in the face of a court, and
- (h) such other proceedings, before any court, tribunal or other person, as may be prescribed.

15 Advice and assistance for criminal proceedings E+W

- (1) Regulations may provide that prescribed advice and assistance is to be available under this Part to an individual described in subsection (2) if—
 - (a) prescribed conditions are met, and
 - (b) the Director has determined that the individual qualifies for such advice and assistance in accordance with the regulations (and has not withdrawn the determination).
- (2) Those individuals are—
 - (a) individuals who are involved in investigations which may lead to criminal proceedings (other than individuals arrested and held in custody at a police station or other premises),
 - (b) individuals who are before a court, tribunal or other person in criminal proceedings, and
 - (c) individuals who have been the subject of criminal proceedings.
- (3) When making the regulations, the Lord Chancellor must have regard, in particular, to the interests of justice.
- (4) The regulations must require the Director to make determinations under the regulations having regard, in particular, to the interests of justice.
- (5) The regulations may require the Director to make such determinations in accordance with—
 - (a) section 21 (financial resources) and regulations under that section, and
 - (b) criteria set out in the regulations.
- (6) The regulations may make provision about the making and withdrawal of determinations under the regulations.
- (7) The regulations may, in particular, include—
 - (a) provision about the form and content of determinations and applications for determinations.
 - (b) provision permitting or requiring applications and determinations to be made and withdrawn in writing, by telephone or by other prescribed means,
 - (c) provision setting time limits for applications and determinations,
 - (d) provision for a determination to be disregarded for the purposes of this Part if made in response to an application that is made otherwise than in accordance with the regulations,
 - (e) provision about conditions which must be satisfied by an applicant before a determination is made.
 - (f) provision about the circumstances in which a determination may or must be withdrawn,
 - (g) provision requiring information and documents to be provided, and
 - (h) provision requiring individuals who are the subject of a determination to be informed of the reasons for making or withdrawing the determination.

- (8) The circumstances prescribed under subsection (7)(f) may, in particular, relate to whether the individual who is the subject of the determination has complied with requirements imposed by or under this Part.
- (9) The regulations may provide for the review of, or appeals to a court, tribunal or other person against, a decision by the Director—
 - (a) that the interests of justice do not require advice or assistance to be made available to an individual under the regulations, or
 - (b) that criteria prescribed under subsection (5)(b) are not met.
- (10) In this section "assistance" includes, in particular, assistance in the form of advocacy.

16 Representation for criminal proceedings E+W

- (1) Representation for the purposes of criminal proceedings is to be available under this Part to an individual if—
 - (a) the individual is a specified individual in relation to the proceedings, and
 - (b) the relevant authority has determined (provisionally or otherwise) that the individual qualifies for such representation in accordance with this Part (and has not withdrawn the determination).
- (2) Representation for the purposes of criminal proceedings is to be available under this Part to an individual if—
 - (a) the proceedings involve the individual resisting an appeal to the Crown Court otherwise than in an official capacity, and
 - (b) the relevant authority has determined (provisionally or otherwise) that the individual qualifies for such representation in accordance with this Part (and has not withdrawn the determination).
- (3) Where an individual qualifies under this Part for representation for the purposes of criminal proceedings ("the principal proceedings"), representation is also to be available to the individual for the purposes of—
 - (a) any related bail proceedings, and
 - (b) any preliminary or incidental proceedings.
- (4) Regulations may—
 - (a) make provision specifying whether proceedings are or are not to be regarded as preliminary or incidental for the purposes of subsection (3), and
 - (b) make provision for exceptions from subsection (3).
- (5) Regulations under subsection (4)(b) may, in particular, make exceptions for proceedings taking place more than a prescribed period of time before or after the principal proceedings.
- (6) In this section—

"the relevant authority", in relation to a specified individual and criminal proceedings, means the person who is authorised by or under section 18, 19 or 20 to determine (provisionally or otherwise) whether the individual qualifies under this Part for representation for the purposes of the proceedings;

"specified individual" means—

- (a) in relation to criminal proceedings mentioned in any of paragraphs (a) to (g) of section 14, an individual mentioned in that paragraph in relation to those proceedings, and
- (b) in relation to criminal proceedings prescribed by regulations under section 14(h), a description of individual specified in the regulations in relation to those proceedings.

17 Qualifying for representation E+W

- (1) The relevant authority must determine whether an individual qualifies under this Part for representation for the purposes of criminal proceedings (whether provisionally or otherwise) in accordance with—
 - (a) section 21 (financial resources) and regulations under that section, and
 - (b) the interests of justice.
- (2) In deciding what the interests of justice consist of for the purposes of such a determination, the following factors must be taken into account—
 - (a) whether, if any matter arising in the proceedings is decided against the individual, the individual would be likely to lose his or her liberty or livelihood or to suffer serious damage to his or her reputation,
 - (b) whether the determination of any matter arising in the proceedings may involve consideration of a substantial question of law,
 - (c) whether the individual may be unable to understand the proceedings or to state his or her own case,
 - (d) whether the proceedings may involve the tracing, interviewing or expert cross-examination of witnesses on behalf of the individual, and
 - (e) whether it is in the interests of another person that the individual be represented.

- (5) In this section "the relevant authority", in relation to an individual and criminal proceedings, means the person who is authorised by or under section 18, 19 or 20 to determine (provisionally or otherwise) whether the individual qualifies under this Part for representation for the purposes of the proceedings.

18 Determinations by Director E+W

- (5) The circumstances prescribed under subsection (4)(f) may, in particular, relate to whether the individual who is the subject of the determination has complied with requirements imposed by or under this Part.
- (6) An appeal lies to such court, tribunal or other person as may be prescribed against a decision by the Director that the interests of justice do not require representation to be made available, or to continue to be made available, to an individual under this Part for the purposes of criminal proceedings, subject to subsection (7).

19 Determinations by court E+W

20 Provisional determinations E+W

Financial resources E+W

- (4) An information request made to the Commissioners under this section may request the disclosure of some or all of the following information—
 - (a) whether or not a relevant individual is employed or was employed at a time specified in the request;
 - (b) the name and address of the employer;
 - (c) whether or not a relevant individual is carrying on a business, trade or profession or was doing so at a time specified in the request;
 - (d) the name under which it is or was carried on;
 - (e) the address of any premises used for the purposes of carrying it on;
 - (f) a relevant individual's national insurance number;
 - (g) a relevant individual's benefit status at a time specified in the request;
 - (h) information of a prescribed description.
- (5) The information that may be prescribed under subsections (3)(f) and (4)(h) includes, in particular, information relating to—
 - (a) prescribed income of a relevant individual for a prescribed period, and
 - (b) prescribed capital of a relevant individual.
- (6) Information may not be prescribed under subsection (4)(h) without the Commissioners' consent.

(7) The Secretary of State, the relevant Northern Ireland Departments and the Commissioners may disclose to the relevant authority information specified in an information request made under this section.

(8) In this section—

"benefit status", in relation to an individual, means whether or not the individual is in receipt of a prescribed benefit or benefits and, if so—

- (b) whether the individual is entitled to the benefit or benefits alone or jointly,
- (c) in prescribed cases, the amount the individual is receiving by way of the benefit (or each of the benefits) ("the benefit amount"), and
- (d) in prescribed cases, where the benefit consists of a number of elements, what those elements are and the amount included in respect of each element in calculating the benefit amount;

"the relevant authority" means—

- (a) a prescribed person, or
- (b) in relation to circumstances for which no person is prescribed, the Director;

"a relevant individual", in relation to an information request for the purposes of a determination about an individual's financial resources, means—

- (a) that individual, and
- (b) any other individual whose financial resources are or may be relevant for the purposes of the determination;

"relevant Northern Ireland Department" means the Department for Social Development in Northern Ireland or the Department of Finance and Personnel in Northern Ireland.

23 Payment for services E+W

 - (b) provision about the time and manner in which payments must be made,
 - (c) provision about the person to whom payments must be made, and
 - (d) provision about what that person must do with the payments.
- (10) The regulations may, in particular, make provision for the payment by an individual of interest, on such terms as may be prescribed, in respect of—
 - (a) a loan made to the individual under this Part,
 - (b) a payment in connection with the provision of services which is not required by the regulations to be made by the individual until after the time when the services are provided, and
 - (c) so much of a payment as remains unpaid after the time when it is required by the regulations to be made by the individual.
- (11) The regulations—

- (a) must make provision for the repayment to an individual of any amount in excess of the individual's liability under the regulations or under section 24, and
- (b) may make provision for the payment of interest on the excess.

(12) In this section—

"administration costs" means costs in connection with the administration of legal aid, including the administration of charges arising under section 25;

"prescribed amount" includes an amount calculated in a prescribed manner.

24 Enforcement E+W

 - (e) provision for the payment to the individual concerned of any amount in excess of the amounts described in subsection (2), and
 - (f) provision for the enforcement of requirements described in paragraph (a).
- (6) Regulations under this section may include provision requiring information and documents to be provided.

26 Costs in civil proceedings E+W

- (1) Costs ordered against an individual in relevant civil proceedings must not exceed the amount (if any) which it is reasonable for the individual to pay having regard to all the circumstances, including—
 - (a) the financial resources of all of the parties to the proceedings, and
 - (b) their conduct in connection with the dispute to which the proceedings relate.
- (2) In subsection (1) "relevant civil proceedings", in relation to an individual, means—
 - (a) proceedings for the purposes of which civil legal services are made available to the individual under this Part, or
 - (b) if such services are made available to the individual under this Part for the purposes of only part of proceedings, that part of the proceedings.

- (4) In assessing for the purposes of subsection (1) the financial resources of an individual to whom civil legal services are made available, the following must not be taken into account, except so far as prescribed—
 - (a) the individual's clothes and household furniture, and
 - (b) the implements of the individual's trade.
- (5) Subject to subsections (1) to (4), regulations may make provision about costs in relation to proceedings for the purposes of which civil legal services are made available under this Part.
- (6) Regulations under subsection (5) may, in particular, make provision—

- (a) specifying the principles to be applied in determining the amount of any costs which may be awarded against a party to whom civil legal services are made available under this Part,
- (b) limiting the circumstances in which, or the extent to which, an order for costs may be enforced against such a party,
- (c) as to the cases in which, and the extent to which, such a party may be required to give security for costs and the manner in which it is to be given,
- (d) requiring the payment by the Lord Chancellor of the whole or part of any costs incurred by a party to whom civil legal services are not made available under this Part,
- (e) specifying the principles to be applied in determining the amount of costs which may be awarded to a party to whom civil legal services are made available under this Part,
- (f) as to the court, tribunal or other person by whom the amount of any costs is to be determined, and
- (g) as to the extent to which any determination of that amount is to be final.
- (7) Regulations may provide that an individual is to be treated, for the purposes of subsection (1) or regulations under subsection (3) or (5), as having or not having financial resources of a prescribed description (but such regulations have effect subject to subsection (4)).
- (8) Regulations under subsection (7) may, in particular, provide that the individual is to be treated as having prescribed financial resources of a person of a prescribed description.
- (9) Regulations under this section may include provision requiring information and documents to be provided.

Providers of services etc

27 Choice of provider of services etc E+W

 - (c) in other circumstances specified by the Lord Chancellor by order.

- (3) The Lord Chancellor may not make an order under subsection (1) or (2) unless the Lord Chancellor considers—
 - (a) that it is necessary to make the order because failure to do so would result in a breach of—
 - (i) an individual's Convention rights (within the meaning of the Human Rights Act 1998), or
 - (ii) any rights of an individual to the provision of legal services that are enforceable EU rights, or
 - (b) that it is appropriate to make the order having regard to any risk that failure to do so would result in such a breach.

Restriction on disclosure of information about financial resources E+W +N.I.

(1) A person to whom information is disclosed under section 22 or this subsection may disclose the information to any person to whom its disclosure is necessary

 - (a) if P is released under this section before that date, P's licence must include a curfew condition complying with section 253, and
 - (b) P is not to be so released (despite subsections (1)(b) and (5)) unless the Secretary of State is satisfied that arrangements are in place to enable that condition to be complied with.
- (8) Subsection (9) applies if, after P has been informed that he or she will be released under this section, the Secretary of State receives further information about P (whether or not relating to any time before P was recalled).

"Supervision of young offenders after release

256B Supervision of young offenders after release

- (1) This section applies where a person ("the offender") is released under this Chapter from one of the following terms if the term is for less than 12 months—
 - (a) a term of detention in a young offender institution;
 - (b) a term of detention under section 91 of the Sentencing Act;
 - (c) a term of detention under section 209 of the Armed Forces Act 2006.
- (2) The offender is to be under the supervision of—
 - (a) an officer of a provider of probation services,
 - (b) a social worker of a local authority, or
 - (c) if the offender is under the age of 18 years at the date of release, a member of the youth offending team.
- (3) Where the supervision is to be provided by an officer of a provider of probation services, the officer must be an officer acting in the local justice area in which the offender resides for the time being.

 - (b) a member of a youth offending team,

the social worker or member must be a social worker of, or a member of a youth offending team established by, the local authority within whose area the offender resides for the time being.

- (5) The supervision period begins on the offender's release and ends three months later (whether or not the offender is detained under section 256C or otherwise during that period).
- (6) During the supervision period, the offender must comply with such requirements, if any, as may for the time being be specified in a notice from the Secretary of State.
- (7) The requirements that may be specified in a notice under subsection (6) include—
 - (a) requirements for securing the electronic monitoring of the offender's compliance with any other requirements specified in the notice;
 - (b) requirements for securing the electronic monitoring of the offender's whereabouts (otherwise than for the purpose of securing compliance with requirements specified in the notice);
 - (c) in the circumstances mentioned in subsection (8), requirements to provide, when instructed to do so by an officer of a provider of probation services or a person authorised by the Secretary of State, any sample mentioned in the instruction for the purpose of ascertaining whether the offender has any specified Class A drug in his or her body.

 - (2) "Relevant period" means any period which would (but for the repeal of section 67 of the Criminal Justice Act 1967) be a relevant period within the meaning of that section (reduction of sentences by period spent in custody etc).
- 4 Section 246 applies as if, in subsection (4)—

- (a) the reference in paragraph (a) to section 227 or 228 were a reference to section 85 of the Sentencing Act;
- (b) the reference in paragraph (d) to paragraph 9(1)(b) or (c) or 10(1)(b) or (c) of Schedule 8 were a reference to paragraph 4(1)(d) or 5(1) (d) of Schedule 3 to the Sentencing Act;
- (c) in paragraph (g)—
 - (i) the reference to section 246 included a reference to section 34A of the 1991 Act,
 - (ii) the reference to section 255(1)(a) included a reference to section 38A(1)(a) or 39(1) or (2) of the 1991 Act, and
 - (iii) the reference to section 255(3) included a reference to section 38A(3) of the 1991 Act;
- (d) the references in paragraph (h) to sections 248 and 254 included references to, respectively, sections 36 and 39(1) or (2) of the 1991 Act; and
- (e) in paragraph (i), the words from "in the case of" to "relates" were omitted.
- 5 (1) Where the person has been released on licence under Part 2 of the 1991 Act or under section 60 of the Criminal Justice Act 1967 before the commencement date, the person is to be treated as if the release had been under this Chapter.
 - (2) In particular, the following provisions apply.
 - (3) A licence under section 34A of the 1991 Act is to be treated as if it were a licence under section 246.
 - (4) A licence under section 36 of the 1991 Act is to be treated as if it were a licence under section 248.
 - (5) Any condition of a licence specified under section 37 of the 1991 Act is to have effect as if it were included under section 250 (whether or not the condition is of a kind which could otherwise be included under that section).

- An order made under section 47 of the 1991 Act is to have effect as if it were an order made under section 243.
- Section 264 applies as if the definition of "custodial period" in subsection (6) included, in relation to an extended sentence imposed under section 85 of the Sentencing Act, one-half of the custodial term determined under that section."

PART 1 E+W

INTRODUCTORY

Interpretation

- (1) The following provisions apply for the purposes of this Schedule.
 - (2) "The commencement date" means the date on which section 121 of the Legal Aid, Sentencing and Punishment of Offenders Act 2012 comes into force.
 - (3) "The 1967 Act" means the Criminal Justice Act 1967.
 - (4) "The 1991 Act" means the Criminal Justice Act 1991.
 - (5) A "section 85 extended sentence" means an extended sentence under section 85 of the Sentencing Act and includes (in accordance with paragraph 1(3) of Schedule 11 to that Act) a sentence under section 58 of the Crime and Disorder Act 1998.
 - (6) In relation to a section 85 extended sentence, "the custodial term" and "the extension period" have the meaning given by that section.
 - (7) References to section 86 of the Sentencing Act include (in accordance with paragraph 1(3) of Schedule 11 to that Act) section 44 of the 1991 Act as originally enacted.

- (8) A "1967 Act sentence" is a sentence imposed before 1 October 1992.
- (9) A "1991 Act sentence" is a sentence which is—
 - (a) imposed on or after 1 October 1992 but before 4 April 2005, or
 - (b) imposed on or after 4 April 2005 but before the commencement date and is either—
 - (i) imposed in respect of an offence committed before 4 April 2005, or
 - (ii) for a term of less than 12 months.
- (10) A "2003 Act sentence" is a sentence which is—
 - (a) imposed on or after the commencement date, or
 - (b) imposed on or after 4 April 2005 but before the commencement date and is both—
 - (i) imposed in respect of an offence committed on or after 4 April 2005, and
 - (ii) for a term of 12 months or more.
- (11) Where an offence is found to have been committed over a period of two or more days, or at some time during a period of two or more days, it is to be taken for the purposes of this Schedule to have been committed on the last of those days.

Explanation of dates

- The following dates (which are mentioned in this Schedule) are dates on which changes to the law relating to the release and recall of prisoners came into force—
 - 1 October 1992 is the date on which Part 2 of the 1991 Act came into force;
 - 30 September 1998 is the date on which certain provisions of the Crime and Disorder Act 1998 came into force;
 - 4 April 2005 is the date on which this Chapter came into force;
 - 9 June 2008 is the date on which section 26 of the Criminal Justice and Immigration Act 2008 came into force;
 - 14 July 2008 is the date on which certain other provisions of that Act came into force;
 - 2 August 2010 is the date on which section 145 of the Coroners and Justice Act 2009 came into force.

PART 2 E+W

PRISONERS SERVING 1991 ACT SENTENCES ETC

- 3 (1) This Part applies to certain persons serving a 1991 Act sentence.
 - (2) This Part also applies to a person serving a 2003 Act sentence which is—
 - (a) a section 85 extended sentence, or
 - (b) an extended sentence imposed under section 227 or 228 before 14 July 2008.

- (3) But this Part does not apply to a person who—
 - (a) has been released on licence under Part 2 of the 1991 Act,
 - (b) has been recalled to prison, and
 - (c) (whether or not having returned to custody in consequence of that recall) is unlawfully at large on the commencement date.

Duty to release on licence at two-thirds of sentence

- 4 (1) This paragraph applies to a person in relation to whom—
 - (a) all the conditions in sub-paragraph (2) are met, and
 - (b) the condition in any one or more of sub-paragraphs (3) to (5) is met.
 - (2) The conditions in this sub-paragraph are that—
 - (a) the person has been convicted of an offence committed before 4 April 2005,
 - (b) the person is serving a sentence of imprisonment imposed in respect of that offence on or after 1 October 1992 but before the commencement date,
 - (c) the sentence or (in the case of a section 85 extended sentence) the custodial term is for a term of 4 years or more, and
 - (d) the person has not previously been released from prison on licence in respect of that sentence.
 - (3) The condition in this sub-paragraph is that the offence (or one of the offences) in respect of which the sentence was imposed is—
 - (a) an offence specified in Schedule 15 (specified violent offences and specified sexual offences) as it had effect on 4 April 2005,
 - (b) an offence under any of sections 11, 12, 15 to 18, 54 and 56 to 63 of the Terrorism Act 2000,
 - (c) an offence under any of sections 47, 50 and 113 of the Antiterrorism, Crime and Security Act 2001,
 - (d) an offence under section 12 of the Sexual Offences Act 1956,
 - (e) an offence of aiding, abetting counselling, procuring or inciting the commission of an offence listed in any of paragraphs (b) to (d), or
 - (f) an offence of conspiring or attempting to commit an offence listed in any of paragraphs (b) to (d).
 - (4) The condition in this sub-paragraph is that the person has served one-half of the sentence or (in the case of a section 85 extended sentence) of the custodial term before 9 June 2008.
 - (5) The condition in this sub-paragraph is that—
 - (a) the person is serving the sentence by virtue of having been transferred to the United Kingdom in pursuance of a warrant under section 1 of the Repatriation of Prisoners Act 1984,
 - (b) the warrant was issued before 9 June 2008, and
 - (c) the offence (or one of the offences) for which the person is serving the sentence corresponds to murder or to any offence specified in Schedule 15 as it had effect on 4 April 2005.

- (1) As soon as a person to whom paragraph 4 applies has served two-thirds of the sentence, it is the duty of the Secretary of State to release the person on licence under this paragraph.
 - (2) If the person is serving a section 85 extended sentence, the reference in subparagraph (1) to two-thirds of the sentence is a reference to two-thirds of the custodial term.
 - (3) Sub-paragraphs (1) and (2) apply in place of section 244 (release on licence of prisoners serving 12 months or more).

Duty to release on direction of Parole Board

- 6 (1) After a person to whom paragraph 4 applies has served one-half of the sentence, the Secretary of State must, if directed to do so by the Board, release the person on licence under this paragraph.
 - (2) The Board must not give a direction under sub-paragraph (1) unless the Board is satisfied that it is no longer necessary for the protection of the public that the person should be confined.
 - (3) If the person is serving a section 85 extended sentence, the reference in subparagraph (1) to one-half of the sentence is a reference to one-half of the custodial term.
 - (4) Sub-paragraphs (1) to (3) apply in place of section 244 (release on licence of prisoners serving 12 months or more).

Release on licence at one-half of sentence: section 85 extended sentence prisoners

- 7 (1) This paragraph applies to a person if—
 - (a) the person has been convicted of an offence committed on or after 30 September 1998 but before 4 April 2005,
 - (b) the person is serving a section 85 extended sentence in respect of that offence,
 - (c) the person has not previously been released from prison on licence in respect of that sentence, and
 - (d) paragraph 4 does not apply to the person.
- 8 (1) As soon as a person to whom paragraph 7 applies has served one-half of the custodial term, it is the duty of the Secretary of State to release the person on licence under this paragraph.
 - (2) Sub-paragraph (1) applies in place of section 243A or 244, as the case may be (release of prisoners serving less than 12 months, or serving 12 months or more).

Duty to release unconditionally at three-quarters of sentence

- 9 (1) This paragraph applies to a person if—
 - (a) the person has been convicted of an offence committed before 30 September 1998,
 - (b) the person is serving a sentence of imprisonment imposed in respect of that offence on or after 1 October 1992,

- (c) the sentence is for a term of 12 months or more,
- (d) the person has been released on licence under Part 2 of the 1991 Act, and
- (e) the person has been recalled before 14 July 2008 (and has not been recalled after that date).
- (2) But this paragraph does not apply if the court by which the person was sentenced ordered that section 86 of the Sentencing Act (extension of periods in custody and on licence in the case of certain sexual offences) should apply.
- As soon as a person to whom paragraph 9 applies would (but for the earlier release) have served three-quarters of the sentence, it is the duty of the Secretary of State to release the person unconditionally.

Duty to release on licence at three-quarters of sentence

- 11 (1) This paragraph applies to a person who—
 - (a) has been convicted of an offence committed on or after 30 September 1998 but before 4 April 2005,
 - (b) is serving a sentence of imprisonment for a term of 12 months or more imposed in respect of that offence,
 - (c) has been released on licence under Part 2 of the 1991 Act, and
 - (d) has been recalled before 14 July 2008 (and has not been recalled after that date).
 - (2) But this paragraph does not apply if the person has been released and recalled more than once.
 - (3) Nor does this paragraph apply if the sentence is a section 85 extended sentence (paragraph 13 applying to such a case instead).
- As soon as a person to whom paragraph 11 applies would (but for the earlier release) have served three-quarters of the sentence, it is the duty of the Secretary of State to release the person on licence.

Release on licence: re-release of section 85 extended sentence prisoners

- 13 (1) This paragraph applies to a person who—
 - (a) has been convicted of an offence committed on or after 30 September 1998 but before 4 April 2005,
 - (b) is serving a section 85 extended sentence imposed in respect of that offence.
 - (c) has been released on licence under Part 2 of the 1991 Act, and
 - (d) has been recalled before 14 July 2008 (and has not been recalled after that date).
 - (2) But this paragraph does not apply if the person has been released and recalled more than once.
- 14 (1) If a person to whom paragraph 13 applies is serving a sentence with a custodial term of less than 12 months, it is the duty of the Secretary of State to release the person on licence as soon as the person would (but for the earlier release) have served the period found by adding—
 - (a) one-half of the custodial term, and

- (b) the extension period.
- (2) If a person to whom paragraph 13 applies is serving a sentence with a custodial term of 12 months or more, it is the duty of the Secretary of State to release the person on licence as soon as the person would (but for the earlier release) have served the period found by adding—
 - (a) three-quarters of the custodial term, and
 - (b) the extension period.

Release of section 227 or 228 extended sentence prisoners: Parole Board direction

- 15 (1) This paragraph applies to a person ("P") who is serving an extended sentence imposed under section 227 or 228 before 14 July 2008.
 - (2) Section 247 (release of prisoner on licence) applies to P with the following modifications.
 - (3) The Secretary of State must not release P under subsection (2) of that section unless the Board has directed P's release under that subsection.
 - (4) The Board must not give a direction under sub-paragraph (3) unless the Board is satisfied that it is no longer necessary for the protection of the public that the person should be confined.
 - (5) As soon as P has served the appropriate custodial term, the Secretary of State must release P on licence, unless P has previously been recalled under section 254.

Licence to remain in force to three-quarters of sentence

- 16 (1) This paragraph applies to a person to whom paragraph 4 applies.
 - (2) This paragraph also applies to a person if—
 - (a) the person has been convicted of an offence committed before 4 April 2005,
 - (b) the person is serving a sentence of imprisonment imposed in respect of that offence on or after 1 October 1992 but before the commencement date,
 - (c) that sentence is for a term of 12 months or more but less than 4 years, and
 - (d) the person has not previously been released from prison on licence in respect of that sentence.
 - (3) This paragraph also applies to a person if—
 - (a) the person has been convicted of an offence committed before 4 April 2005,
 - (b) the person is serving a sentence of imprisonment imposed in respect of that offence on or after 1 October 1992,
 - (c) that sentence is for a term of 12 months or more,
 - (d) the person has been released on licence under Part 2 of the 1991 Act, and
 - (e) the person has been recalled before 14 July 2008 (and has not been recalled after that date).

- (5) Nor does this paragraph apply if—
 - (a) the person is serving a section 85 extended sentence, or
 - (b) the court by which the person was sentenced ordered that section 86 of the Sentencing Act (extension of periods in custody and on licence in the case of certain sexual offences) should apply.
- (6) If a person has been—
 - (a) released under section 34A of the 1991 Act or section 246 (home detention curfew), and
 - (b) recalled under section 38A(1)(b) of the 1991 Act or section 255(1) (b) (no longer possible to monitor curfew),

the release and recall are to be disregarded for the purposes of this paragraph.

- 17 (1) Where a person to whom paragraph 16 applies is released on licence under section 244 or paragraph 5 or 6, the licence shall remain in force until the date on which the person would (but for the release) have served three-quarters of the sentence.
 - (2) Sub-paragraph (1) is subject to any revocation under section 254.
 - (3) Sub-paragraphs (1) and (2) apply in place of section 249 (duration of licence).

Period for which licence to remain in force: section 85 extended sentence prisoners

- 18 This paragraph applies to a person who—
 - (a) has been convicted of an offence committed on or after 30 September 1998 but before 4 April 2005,
 - (b) is serving a section 85 extended sentence imposed in respect of that offence, and
 - (c) has not previously been released from prison on licence in respect of that sentence.
- 19 (1) Where a person to whom paragraph 18 applies is released on licence and the custodial term is less than 12 months, the licence shall remain in force until the end of the period found by adding—
 - (a) one-half of the custodial term, and
 - (b) the extension period.
 - (2) Where a person to whom paragraph 18 applies is released on licence and the custodial term is 12 months or more, the licence shall remain in force until the end of the period found by adding—
 - (a) three-quarters of the custodial term, and
 - (b) the extension period.
 - (3) Sub-paragraphs (1) and (2) are subject to any revocation under section 254.
 - (4) Sub-paragraphs (1) to (3) apply in place of section 249 (duration of licence).

Concurrent or consecutive terms

- Paragraphs 21 and 22 apply where a person ("P") is serving two or more sentences of imprisonment imposed on or after 1 October 1992 and—
 - (a) the sentences were passed on the same occasion, or
 - (b) where they were passed on different occasions, the person has not been released under Part 2 of the 1991 Act or under this Chapter at any time during the period beginning with the first and ending with the last of those occasions.
- 21 (1) This paragraph applies if each of the sentences is a 1991 Act sentence.
 - (2) Sections 263 and 264 (consecutive and concurrent terms) do not apply in relation to the sentences.
 - (3) For the purposes of any reference in this Chapter, however expressed, to the term of imprisonment to which P has been sentenced or which, or part of which, P has served, the terms are to be treated as a single term.
 - (4) If one or more of the sentences is a section 85 extended sentence—
 - (a) for the purpose of determining the single term mentioned in subparagraph (3), the extension period or periods is or are to be disregarded, and
 - (b) the period for which P is to be on licence in respect of the single term is to be increased in accordance with sub-paragraph (5).
 - (5) That period is to be increased—
 - (a) if only one of the sentences is a section 85 extended sentence, by the extension period;
 - (b) if there is more than one such sentence and they are wholly or partly concurrent, by the longest of the extension periods;
 - (c) if there is more than one such sentence and they are consecutive, by the aggregate of the extension periods.
- 22 (1) This paragraph applies where two or more sentences are to be served consecutively on each other and—
 - (a) one or more of those sentences is a 1991 Act sentence, and
 - (b) one or more of them is a 2003 Act sentence.
 - (2) Section 264 does not affect the length of the period which P must serve in prison in respect of the 1991 Act sentence or sentences.
 - (3) Nothing in this Chapter requires the Secretary of State to release P until P has served a period equal in length to the aggregate of the length of the periods which P must serve in relation to each of the sentences mentioned in subparagraph (1).
 - (4) If P is also serving one or more 1967 Act sentences, paragraphs 32 and 33 apply instead of this paragraph.

PART 3 E+W

PRISONERS SERVING 1967 ACT SENTENCES

 - (3) But this paragraph does not apply if, on the passing of the sentence, an extended sentence certificate was issued (see paragraph 27).
 - (4) If a person has been—
 - (a) released under section 34A of the 1991 Act or section 246 (home detention curfew), and
 - (b) recalled under section 38A(1)(b) of the 1991 Act or section 255(1) (b) (no longer possible to monitor curfew),

the release and recall are to be disregarded for the purposes of this paragraph.

- 25 (1) It is the duty of the Secretary of State to release a person to whom paragraph 24 applies unconditionally under this paragraph—
 - (a) in the case of a person falling within paragraph 24(1), as soon as the person has served two-thirds of the sentence;
 - (b) in the case of a person falling within paragraph 24(2), as soon as the person would (but for the earlier release) have served two-thirds of the sentence.

- (2) After a person falling within paragraph 24(1) has served one-third of the sentence or six months, whichever is longer, the Secretary of State must, if directed to do so by the Board, release the person on licence under this paragraph.
- (3) The Board must not give a direction under sub-paragraph (2) unless the Board is satisfied that it is no longer necessary for the protection of the public that the person should be confined.
- (4) Sub-paragraphs (1) to (3) apply in place of section 244 (release on licence of prisoners serving 12 months or more).
- 26 (1) Where a person to whom paragraph 24 applies is released on licence under paragraph 25(2), the licence shall remain in force until the date on which the person would (but for the release) have served two-thirds of the sentence.
 - (2) Sub-paragraph (1) is subject to any revocation under section 254.
 - (3) Sub-paragraphs (1) and (2) apply in place of section 249 (duration of licence).

Extended sentence of more than 12 months imposed before 1 October 1992

- 27 (1) This paragraph applies to a person if—
 - (a) the person is serving a sentence of imprisonment imposed before 1 October 1992.
 - (b) the sentence is for a term of more than 12 months,
 - (c) on the passing of the sentence an extended sentence certificate was issued, and
 - (d) the person has not previously been released from prison on licence in respect of that sentence.
 - (2) This paragraph also applies to a person if—
 - (a) the person is serving a sentence of imprisonment imposed before 1 October 1992,
 - (b) the sentence is for a term of more than 12 months,
 - (c) on the passing of the sentence an extended sentence certificate was issued,
 - (d) the person has been released on licence under Part 2 of the 1991 Act, and
 - (e) the person has been recalled before 14 July 2008 (and has not been recalled after that date).
 - (3) In this paragraph "extended sentence certificate" means a certificate was issued under section 28 of the Powers of Criminal Courts Act 1973 (punishment of persistent offenders) stating that an extended term of imprisonment was imposed on the person under that section.
- 28 (1) It is the duty of the Secretary of State to release a person to whom paragraph 27 applies on licence under this paragraph—
 - (a) in the case of a person falling within paragraph 27(1), as soon as the person has served two-thirds of the sentence;

- (b) in the case of a person falling within paragraph 27(2), as soon as the person would (but for the earlier release) have served two-thirds of the sentence.
- (2) After a person falling within paragraph 27(1) has served one-third of the sentence or six months, whichever is longer, the Secretary of State must, if directed to do so by the Board, release the person on licence under this paragraph.
- (3) The Board must not give a direction under sub-paragraph (2) unless the Board is satisfied that it is no longer necessary for the protection of the public that the person should be confined.
- (4) Sub-paragraphs (1) to (3) apply in place of section 244 (release on licence of prisoners serving twelve months or more).

Additional days

- 29 (1) Prison rules made by virtue of section 257 may include provision for applying any provisions of this Chapter, in relation to any person falling within sub-paragraph (2), as if the person had been awarded such number of additional days as may be determined by or under the rules.
 - (2) A person falls within this sub-paragraph if—

 - (a) for the purpose of determining the single term mentioned in subparagraph (3), the extension period or periods is or are to be disregarded, and
 - (b) the period for which P is to be on licence in respect of the single term is to be increased in accordance with sub-paragraph (5).
- (5) That period is to be increased—
 - (a) if only one of the sentences is a section 85 extended sentence, by the extension period;
 - (b) if there is more than one such sentence and they are wholly or partly concurrent, by the longest of the extension periods;
 - (c) if there is more than one such sentence and they are consecutive, by the aggregate of the extension periods.
- (6) If P is also serving a 2003 Act sentence, sub-paragraph (3) is to be applied before the period mentioned in section 263(2)(c) (concurrent terms) or paragraph 33(3) (consecutive terms) is calculated.
- 33 (1) This paragraph applies where two or more sentences are to be served consecutively on each other and—
 - (a) one or more of those sentences is a 1967 Act sentence, and
 - (b) one or more of them is a 2003 Act sentence.

 - (3) Nothing in this Chapter requires the Secretary of State to release P until P has served a period equal in length to the aggregate of the length of the periods which P must serve in relation to each of the sentences mentioned in subparagraph (1).

PART 4 E+W

PROVISIONS APPLYING GENERALLY

Licence conditions

 - (i) making recommendations as to the inclusion or insertion of a condition in a licence granted to P (including by making a recommendation that no condition should be included in such a licence), or
 - (ii) making recommendations as to the variation or cancellation of any such condition (including a recommendation that the condition should not be varied or cancelled).
- (6) The Secretary of State must not—
 - (a) include on release, or subsequently insert, a condition in a Parole Board licence, or
 - (b) vary or cancel any such condition, except in accordance with directions of the Board.

Fine defaulters and contemnors

- 35 (1) This paragraph applies to any person if—
 - (a) the person has been committed to prison or to be detained under section 108 of the Sentencing Act—
 - (i) in default of payment of a sum adjudged to be paid by a conviction, or
 - (ii) for contempt of court or any kindred offence,
 - (b) the person was so committed or detained before 4 April 2005, and
 - (c) the term for which the person was committed or detained is 12 months or more.
 - (2) As soon as a person to whom this paragraph applies has served two-thirds of the term, it is the duty of the Secretary of State to release the person unconditionally.
 - (3) Sub-paragraph (2) applies in place of section 258(2) (early release of fine defaulters and contemnors).

(2) Sub-paragraph (1) applies whether or not the Board has directed the person's release under paragraph 6, 15, 25 or 28."




