INFORMATION: RESTRICTIONS ON DISCLOSURE

PART 1

STATUTORY RESTRICTIONS

- 1 ^[F1](1) This Part of this Act does not authorise or require—
- (a) a disclosure, in contravention of any provisions of ^[F2]the data protection legislation], of personal data which ^[F3]is] not exempt from those provisions, or
 - (b) a disclosure which is prohibited by ^[F4]any of Parts 1 to 7 or Chapter 1 of Part 9 of the Investigatory Powers Act 2016].
- ^[F5](2) In this paragraph, “the data protection legislation” has the same meaning as in the Data Protection Act 2018 (see section 3 of that Act).]
