Excesses for 2014-15

4 Authorisation of excesses for 2014-15

- (1) The amount up to which authorisation was conferred for the use of resources for the year ending with 31 March 2015 is to be treated as further increased, for the purpose of making good excesses, by £105,229,000.
- (2) Of the further amount treated as authorised by subsection (1)—
 - (a) £104,823,000 is to be treated as authorised for use for current purposes; and
 - (b) £406,000 is to be treated as authorised for use for capital purposes.
- (3) The amount up to which authorisation was conferred on the Treasury—
 - (a) to issue money out of the Consolidated Fund, and
 - (b) to apply it in the year ending with 31 March 2015 for expenditure authorised by Parliament,is to be treated as further increased, for the purpose of making good excesses, by £275,000.
- (4) The increases for which this section provides are to be treated as having had effect from the beginning of 1 April 2014.

Changes to legislation:
