- 27 (1) The listed GDPR provisions do not apply to personal data processed for—

- This is subject to [F1sub-paragraphs (3) and (4)].
- (2) For the purposes of this paragraph, the listed GDPR provisions are the following provisions of the [F2UK GDPR]—
- Article 15(1) to (3) (confirmation of processing, access to data and safeguards for third country transfers);
 - Article 16 (right to rectification);
 - Article 18(1) (restriction of processing);
 - Article 21(1) (objections to processing).
- (3) The exemption in sub-paragraph (1) is available only where—
- the personal data is processed in accordance with Article 89(1) of the [F3UK GDPR] (as supplemented by section 19), and
