General principles of EU law

- 2 No general principle of EU law is part of domestic law on or after [^{F1}IP completion day] if it was not recognised as a general principle of EU law by the European Court in a case decided before [^{F1}IP completion day] (whether or not as an essential part of the decision in the case).

- 3 (1) There is no right of action in domestic law on or after [^{F1}IP completion day] based on a failure to comply with any of the general principles of EU law.
- (2) No court or tribunal or other public authority may, on or after [^{F1}IP completion day] —
- (a) disapply or quash any enactment or other rule of law, or
 - (b) quash any conduct or otherwise decide that it is unlawful,
- because it is incompatible with any of the general principles of EU law.
