GENERAL PROVISION ABOUT POWERS UNDER ACT

Anticipatory exercise of powers in relation to retained EU law

- 24 Any power to make regulations under this Act which modify retained direct EU legislation, anything which is retained EU law by virtue of section 4 or any other retained EU law is capable of being exercised before [^{F1}IP completion day] so that the regulations come into force on or after [^{F1}IP completion day].
