#### 142 Default powers of Minister.

(1) Where the Minister is of opinion, on complaint or otherwise, that a [<sup>F12</sup>local social services authority] have failed to carry out functions conferred or imposed on the

authority by or under this Act or have in carrying out those functions failed to comply with any regulations relating thereto, he may after such inquiry as he thinks fit make an order declaring the authority to be in default.

(2) Subsections (3) to (5) of [<sup>F13</sup>section 85 of the <sup>M1</sup>National Health Service Act 1977] (which relates to orders declaring, among others, a local authority to be in default under that Act) shall apply in relation to an order under this section as they apply in relation to an order under that section.

#### 143 Inquiries.

The Minister may cause an inquiry to be held in any case where he thinks it advisable to do so in connection with any matter arising under this Act, and [<sup>F14</sup>subsections (2) to (5) of section 250 of the <sup>M2</sup>Local Government Act 1972] shall apply to any inquiry held under this Act, except that no local authority shall be ordered to pay costs under subsection (4) of that section in the case of any inquiry unless the authority is a party thereto.
