



# Revenue, Friendly Societies, and National Debt Act 1882

1882 CHAPTER 72 45 and 46 Vict

An Act for amending the Laws relating to Customs and Inland Revenue, and Postage and other Stamps, and for making further provision respecting the National Debt and charges payable out of the public revenue or by the Commissioners for the Reduction of the National Debt; and for other purposes. [18th August 1882]

## 1 Short title.

**[<sup>F13</sup>18 Adjustment of account as regards accumulations of fractions of a penny on the dividends of the National Debt**

The Registrar of Government Stock shall from time to time, when required by the Treasury, certify to the Treasury the amount in his hands arising from fractions of a penny not paid on account of dividends on the national debt, and the Treasury may by warrant direct the Registrar of Government Stock to repay the same to the National Loans Fund.<sup>F13</sup>]

The dividends payable in respect of the two pounds [<sup>F14</sup>50p] per centum annuities mentioned in the first schedule to the <sup>M1</sup>National Debt Act 1870, shall be paid quarterly, on the fifth day of January, the fifth day of April, the fifth day of July, and the fifth day of October in every year . . . <sup>F15</sup>

.....<sup>F20</sup> Such rights of Her Majesty as are herein-after mentioned shall be deemed to have been vested in Her Majesty in right of Her Crown as from and after the first day of January, one thousand eight hundred and eighty-one.

The rights of Her Majesty to which this section applies are:—

- (a) Any right vested in Her Majesty to any escheat or forfeiture of land lying within any liberty of the Duchy of Lancaster which is not situated in the county of Lancaster, not being an escheat or forfeiture of land holden of any manor vested in Her Majesty in right of Her Duchy of Lancaster;
- (b) Any right vested in Her Majesty to the personal estate of any person dying intestate and without next of kin who is domiciled within any such liberty;
