



# Disused Burial Grounds Act 1884

1884 CHAPTER 72 47 and 48 Vict

An Act for preventing the erection of Buildings on Disused Burial  
Grounds. [14th August 1884]

**1 Short title.**

This Act may be cited as the Disused Burial Grounds Act 1884.

**2 Interpretation.**

In this Act a “disused burial ground” shall mean a burial ground in respect of which an Order in Council has been made for the discontinuance of burials therein in pursuance of the provisions of the said recited Acts.

**3 No buildings to be erected upon disused burial grounds except for enlargement, &c.**

It shall not be lawful to erect any buildings upon any disused burial ground, except for the purpose of enlarging a church, chapel, meeting house, or other places of worship.

**4 Savings for buildings already sanctioned.**

Nothing in this Act shall prevent the erection of any building on a disused burial ground for which a faculty has been obtained before the passing of this Act.

**5 Savings of burial grounds sold by Act of Parliament.**

Nothing in this Act contained shall apply to any burial ground which has been sold or disposed of under the authority of any Act of Parliament.
