



Police (Property) Act 1897

1897 CHAPTER 30 60 and 61 Vict

[^{F1}2A Application to [^{F2}the National Crime Agency]

- (1) This Act applies to property which has come into the possession of the [^{F3}National Crime Agency] as it applies to property that has come into the possession of the police.
- (2) In relation to property that has come into the possession of the [^{F4}National Crime Agency] —
 - (a) the reference in section 1(1) to an officer of police is a reference to a [^{F5}National Crime Agency officer] ; and
 - (b) references in section 2 to the property remaining in the possession of the police are references to its remaining in the possession of that [^{F6}Agency].
- (3) The power to make regulations under section 2 has effect in relation to property that has come into the possession of the [^{F7}National Crime Agency] as if—
 - (a) the relevant authority for the purposes of subsection (2A) of that section were [^{F8}that Agency]; and
 - (b) the reference in subsection (2A)(c) of that section to police purposes were a reference to the purposes of that [^{F9}Agency].
