

Police (Property) Act 1897

1897 CHAPTER 30 60 and 61 Vict

[F12A Application to F2the National Crime Agency]

- (1) This Act applies to property which has come into the possession of the [F3National Crime Agency] as it applies to property that has come into the possession of the police.
- (2) In relation to property that has come into the possession of the [F4National Crime Agency]
 - (a) the reference in section 1(1) to an officer of police is a reference to a [F5 National Crime Agency officer]; and
 - (b) references in section 2 to the property remaining in the possession of the police are references to its remaining in the possession of that [F6Agency].
- (3) The power to make regulations under section 2 has effect in relation to property that has come into the possession of the [F7]National Crime Agency] as if—
 - (a) the relevant authority for the purposes of subsection (2A) of that section were [F8that Agency]; and
 - (b) the reference in subsection (2A)(c) of that section to police purposes were a reference to the purposes of that [F9Agency].]
