# The Dredge Corn (Great Britain and Northern Ireland) (Amendment) Order, 1952

24th June, 1952 Made -Laid before Parliament 25th June, 1952 1st July, 1952 Coming into Operation

The Minister of Food, in pursuance of the powers conferred upon him by Regulations 55 and 55AB of the Defence (General) Regulations, 1939, as having effect by virtue of the Supplies and Services (Transitional Powers) Act, 1945(a) (as extended by the Supplies and Services (Extended Purposes) Act, 1947(b) and the Supplies and Services (Defence Purposes) Act, 1951(c), and continued in force by the Supplies and Services (Continuance) Order, 1951(d)), and of all other powers him enabling in that behalf, hereby orders as follows: —

- 1. This Order shall come into operation on the 1st day of July, 1952, and may be cited as the Dredge Corn (Great Britain and Northern Ireland) (Amendment) Order, 1952.
- 2. The Dredge Corn (Great Britain) Order, 1951, as amended(e), and the Dredge Corn (Northern Ireland) Order, 1951, as amended(f), shall be further amended as follows:-
  - (a) by substituting for the First Schedule to each Order the First Schedule to this Order:
  - (b) by substituting for the Second Schedule to each Order the Second Schedule to this Order.
- 3. The Dredge Corn (Great Britain) Order, 1951, as amended, shall be further amended by substituting in paragraph (1) of Article 9 thereof for the figure "1s. 9d." (being the price of M.A.F. sacks) the figure "1s. 8d.".
- 4. The Dredge Corn (Great Britain and Northern Ireland) (Amendment No. 2) Order, 1951(g), and the Dredge Corn (Great Britain and Northern Ireland) (Amendment No. 3) Order, 1951(h), are hereby revoked but without prejudice to any proceedings in respect of any contravention of the Dredge Corn (Great Britain) Order, 1951, or the Dredge Corn (Northern Ireland) Order, 1951, as amended thereby.

## PART II.—CHARGES WHICH MAY BE MADE BY THE SELLER IN ADDITION TO THE MAXIMUM PRICES

# 1. Credit

The maximum prices prescribed by this Order are fixed on the basis of net cash; where credit is given by the seller to the buyer a reasonable charge may be made therefor, provided that the amount of such charge is quoted by the seller on the invoice.

# 2. Transport Charges

The maximum prices prescribed by this Order are fixed on the basis that all transport charges after sale by the grower "ex-farm" are for the account of the ultimate buyer, and accordingly there may be added to such maximum prices all transport charges after sale by the grower "ex-farm"; provided that the charges so added shall not exceed any reasonable amounts actually and properly paid or payable and any other reasonable sums representing transport costs properly incurred.

## 3. Sacks

- (1) Where the seller provides returnable sacks (owned or hired by him) he may make a reasonable charge therefor, provided that—
  - (a) he specifies on an invoice to be furnished to the buyer—
    - (i) the amount of such charge or the rate thereof;
    - (ii) whether or not such charge or any part thereof is made by way of deposit; and
    - (iii) if part of such charge is made by way of deposit, the amount thereof;
  - (b) any charge made by way of deposit shall be repaid by the seller to the buyer on the re-delivery by the buyer of the sack (carriage paid) in such condition as is reasonable having regard to its condition when supplied and to ordinary wear and tear.
- (2) Where the seller provides non-returnable sacks, other than M.A.F. sacks, the seller may make a charge for each sack at a rate not exceeding 1s. 6d. per cwt. of the contents sold, or, in the case of a sale of less than 1 cwt., at a rate not exceeding 1s. 9d. per cwt.

# 4. Storage and Handling Charges

Subject as hereafter in this paragraph provided—

where dredge corn, which has been taken into and delivered out of the seller's store, has at the request of the buyer been delivered by the seller in a quantity of 80 cwt. or less a charge at a rate not exceeding 3½d. per cwt. may be made by the seller in respect of such quantity:

Provided that no such charge may be made on a sale by a grower or where the dredge corn has been taken into the seller's store for the purpose of processing.

#### 5. Small Lots

Where on a sale to an ultimate buyer dredge corn is at the request of the buyer delivered by the seller in any of the undermentioned quantities a charge may be made by the seller in accordance with the following scale:—

#### 6. Prohibition of Further Additions

Except as provided in this Part of this Schedule no charge shall be made in addition to the maximum prices in respect of credit, breaking bulk, transport, containers, storage or handling.

## EXPLANATORY NOTE

(This Note is not part of the Order, but is intended to indicate its general purport.)

This amending Order sets out the maximum prices for millable dredge corn in Great Britain and Northern Ireland for each month from July, 1952, to June, 1953, inclusive, and increases the minimum price for millable dredge corn on a sale by a grower.

The maximum permitted charge for non-returnable sacks, other than M.A.F. sacks, is reduced to 1s. 6d. per cwt. of contents, or on a sale of less than 1 cwt. to 1s. 9d. per cwt., and the price of M.A.F. sacks is reduced from 1s. 9d. to 1s. 8d.
