RESERVE AND AUXILIARY FORCES

The Reserve Forces Act 1966 (Commencement) Order 1966

Made - - - - 22nd September 1966

The Secretary of State in exercise of his powers under sections 21(1) and 25(2) of the Reserve Forces Act 1966(a) (hereinafter referred to as "the said Act") and all other powers enabling him hereby makes the following Order:—

1. Section 20 of the said Act, paragraph 3 of Schedule 1 thereto and so much of Schedule 2 thereto as repeals any provision of the Militia Act 1882(b), the Deputy Lieutenants Act 1918(c) and the Administration of Justice Act 1964(d) shall come into force on 1st November 1966.

2. The provisions of the said Act specified in the Schedule to this Order shall come into force on 1st April 1967.

3. All other provisions of the said Act shall come into force on 1st October 1966.

4. This Order may be cited as the Reserve Forces Act 1966 (Commencement) Order 1966.
