**The National Health Service (General Dental Services)
(Scotland) Amendment Regulations 1966**

<i>Made</i> - - - -	31st January 1966
<i>Laid before Parliament</i>	4th February 1966
<i>Coming into Operation</i>	5th February 1966

In exercise of the powers conferred on me by Sections 39 and 72 of the National Health Service (Scotland) Act 1947(a), as amended(b), and of all other powers enabling me in that behalf, I hereby make the following regulations :—

1.—(1) These regulations may be cited as the National Health Service (General Dental Services) (Scotland) Amendment Regulations 1966 and shall come into operation on 5th February 1966.

(2) The Interpretation Act 1889(c) applies for the interpretation of these regulations as it applies for the interpretation of an Act of Parliament.

2. The National Health Service (General Dental Services) (Scotland) Regulations 1955(d), as amended(e), shall be amended as follows :—

For regulation 32 (which provides for an additional payment to dental practitioners) there shall be substituted the following regulation :—

“ Additional payment to practitioner

32.—(1) Subject to the following provisions of this Regulation the Council shall pay to a practitioner in addition to the fees authorised under regulation 28 of these regulations a sum equal to 5% of the amount of those fees.

(2) This Regulation shall have effect only as respects any payment made to a dental practitioner in pursuance of any advice of payment from the Board to a Council, being an advice dated on or after 5th February 1966, in respect of general dental services provided under a contract or arrangement entered into or made on or after 1st January 1966.”

3. The provisions of these regulations shall not apply as respects any payment to a dental practitioner not in pursuance of such an advice of payment as is mentioned in the foregoing provisions of these regulations, and any such payment shall continue to be subject to the provisions of the

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

These regulations further amend the National Health Service (General Dental Services) (Scotland) Regulations 1955 by providing for additional payments equal to 5 per cent. of their fees, as respects advices of payment from the Scottish Dental Estimates Board to an Executive Council dated on or after 5th February 1966, in respect of treatment given under contracts or arrangements entered into or made on or after 1st January 1966, to dental practitioners who provide general dental services (other than to practitioners employed by a Council at a health centre). In respect of other advices of payment the existing additional payments are maintained.
