We, the Fees Committee constituted in accordance with the provisions of section 1 of the Ecclesiastical Fees Measure 1962(a), in the exercise of the powers conferred by that section, do hereby order as follows:—

1. The Table of Fees set forth in the Schedule to this Order is hereby established and contains particulars of the fees which are to be demanded taken and received by the respective legal officers named in the Schedule for the performance by them after the commencement of this Order of the duties of their offices in relation to the respective matters specified in the Schedule.

2. Where a fee in the Table set forth in the Schedule to this Order replaces a fee established by The Legal Officers Fees Order 1964(b) the fee established by that Order shall cease to have effect.

3. This Order may be cited as The Legal Officers Fees Order 1967 and shall come into operation on the 1st January 1968.
