# The Wages Regulation (Milk Distributive) (Scotland) (Amendment) Order 1968

Made - - 11th December 1968

Coming into Operation 15th January 1969

Whereas the Secretary of State has received from the Milk Distributive Wages Council (Scotland) the wages regulation proposals set out in the Schedule hereto;

Now, therefore, the Secretary of State in exercise of her powers under section 11 of the Wages Councils Act 1959(a), and of all other powers enabling her in that behalf, hereby makes the following Order :---

1. This Order may be cited as the Wages Regulation (Milk Distributive) (Scotland) (Amendment) Order 1968.

2.—(1) In this Order the expression "the specified date" means the 15th January 1969, provided that where, as respects any worker who is paid wages at intervals not exceeding seven days, that date does not correspond with the beginning of the period for which the wages are paid, the expression "the specified date" means, as respects that worker, the beginning of the next such period following that date.

(2) The Interpretation Act 1889(b) shall apply to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.

3. The wages regulation proposals set out in the Schedule hereto shall have effect as from the specified date.

2. in paragraph 17, which relates to definitions, there were inserted the following: -

"' ASSISTANT ROUNDSWOMAN' means a worker wholly or mainly employed in assisting any person carrying out the duties normally performed by a roundswoman whether or not such person is a roundswoman as defined in this Schedule.

'ROUNDSWOMAN' means a worker wholly or mainly employed as a saleswoman on a definite or established route and responsible for keeping account of retail sales to customers and of any cash or tokens received in payment and who is not accompanied, save in exceptional circumstances, by any other person who exercises control or supervision."

## **EXPLANATORY NOTE**

#### (This Note is not part of the Order.)

This Order, which has effect from 15th January 1969, amends the Wages Regulation (Milk Distributive) (Scotland) Order 1967 (Order M.D.S. (91)) by increasing the statutory minimum remuneration fixed by that Order.
