AGRICULTURE

The Agricultural Credits Fees Order 1968

Made - - - 26th April 1968

Coming into Operation 1st June 1968

The Lord Chancellor and the Treasury, in exercise of the powers conferred on them by section 9 of the Agricultural Credits Act 1928(a), and sections 2 and 3 of the Public Offices Fees Act 1879(b), hereby make and approve the following instrument :—

1.—(1) This instrument may be cited as the Agricultural Credits Fees Order 1968 and shall come into operation on 1st June 1968.

(2) The Interpretation Act 1889(c) shall apply to this instrument as it applies to the interpretation of an Act of Parliament.

(3) In this instrument, unless the context otherwise requires—

“the Act” means the Agricultural Credits Act 1928 ;

“fee” means a fee specified in the Schedule ;

“the Schedule” means the Schedule to this instrument.

2. The fees specified in the Schedule shall be payable under the Act.

3. Every fee shall be prepaid in cash or by means of Land Registry adhesive stamps.

4. Where the amount payable in respect of a fee is not immediately ascertainable, such deposit shall be made as the Registrar shall direct.

5. The Agricultural Credits Fees Order 1928(d) is hereby revoked.

EXPLANATORY NOTE

(This Note is not part of the Order.)

This instrument, which supersedes the Agricultural Credits Fees Order 1928, amends the fees payable in connection with the registration and disclosure of agricultural charges under the Agricultural Credits Act 1928. A standard fee of 2s. 6d. is prescribed for all items except the minimum fees for telegraphing and telephoning the result of an official search, which are fixed at 7s. 6d. and 5s. 0d. respectively.
