INDUSTRIAL TRAINING**The Industrial Training (Engineering Board) Order 1968
(Amendment) Order 1969***Made* - - - 22nd September 1969*Laid before Parliament* 6th October 1969*Coming into Operation* 10th October 1969

The Secretary of State after consultation with the Engineering Industry Training Board and with organisations and associations of organisations appearing to be representative respectively of substantial numbers of employers engaging in the activities hereinafter mentioned and of substantial numbers of persons employed in those activities and with the bodies established for the purpose of carrying on under national ownership industries in which the said activities are carried on to a substantial extent and in exercise of her powers under section 9 of the Industrial Training Act 1964(a) and of all other powers enabling her in that behalf hereby makes the following Order :—

Citation, commencement and interpretation

1.—(1) This Order may be cited as the Industrial Training (Engineering Board) Order 1968 (Amendment) Order 1969 and shall come into operation on 10th October 1969.

(2) In this Order—

- (a) “the Act” means the Industrial Training Act 1964 ;
- (b) “the Board” means the Engineering Industry Training Board ;
- (c) “Levy Order” includes the Industrial Training Levy (Engineering) Order 1965(b), the Industrial Training Levy (Engineering) Order 1967(c), the Industrial Training Levy (Engineering) (No. 2) Order 1967(d), the Industrial Training Levy (Engineering) Order 1968(e) and the Industrial Training Levy (Engineering) (No. 2) Order 1967 (Amendment) Order 1968(f) ;
- (d) “the 1968 Order” means the Industrial Training (Engineering Board) Order 1968(g) ;
- (e) “the principal Order” means the Industrial Training (Engineering Board) Order 1964(h).

(3) The Interpretation Act 1889(i) shall apply to the interpretation of this Order as it applies to the interpretation of an Act of Parliament and as if this Order, the principal Order and the 1968 Order were Acts of Parliament.

Amendment of the 1968 Order

2. The 1968 Order (which substituted the Schedule to that Order for Schedule 1 to the principal Order) shall be amended in accordance with the Schedule

to this Order, and accordingly the activities in relation to which the Board exercises the functions conferred by the Act upon industrial training boards shall, in lieu of the activities specified in the Schedule to the 1968 Order, be the activities specified in that Schedule as amended by the Schedule to this Order.

Transitional provisions

3.—(1) The chairman and other members of the Board on the day upon which this Order comes into operation shall continue to be members of the Board and to hold and vacate their offices in accordance with the terms of the instruments appointing them to be members.

(2) The provisions of this Order shall not—

(a) extend the operation of a Levy Order ;

(b) affect the operation of a Levy Order in relation to the assessment of an employer within the meaning of that Order in respect of an establishment that was engaged in the relevant levy period wholly or mainly in activities included in the Schedule to the 1968 Order as amended by the Schedule to this Order ;

(c) affect the operation of any assessment notice served by the Board under the provisions of a Levy Order before the date upon which this Order comes into operation or any appeal or other proceedings arising out of any such notice.

Article 2

SCHEDULE

AMENDMENTS TO THE 1968 ORDER

1. In this Schedule the expression “the Schedule” means the Schedule to the 1968 Order.

2.—(1) Paragraph 1 of the Schedule shall be amended as follows.

(2) In sub-paragraph (b) for the words “or repair” there shall be substituted the words “or, except in the case of vehicle bodies, the repair”.

(3) In sub-paragraph (c) (which relates to the painting or paint spraying of certain articles specified in sub-paragraph (a)) the reference to head (iii) of the last mentioned sub-paragraph shall be omitted.

(4) Sub-paragraph (j) (which refers to the assembly of electric blankets) shall be omitted.

3.—(1) Paragraph 2 of the Schedule shall be amended as follows.

(2) In item 20 of the Table to sub-paragraph (c) for the words “harpichords, spinets, clavichords, pipe-organs and organ pipes” in the third column there shall be substituted the words “and other stringed keyboard instruments, organs and organ pipes”.

(3) In item 25 of the said Table all the words in the second column after the word “Repair” shall be omitted.

(4) In the said Table immediately after item 25 there shall be inserted a new item as follows

(5) In item 39 of the said Table after the words "executive cases" in the third column there shall be inserted the words "picnic cases".

(6) In item 42 of the said Table in the third column the word "and" shall be omitted and after the words "trouser, costume or dress belts" there shall be inserted the words "and cases for travellers' samples".

(7) In item 43 of the said Table after the word "collars" in the third column there shall be inserted the word "harnesses".

(8) In item 48 of the said Table after the words "artificial teeth" in the third column there shall be inserted the word "crowns".

(9) In sub-paragraph (d) in lieu of the words "any operations in" there shall be substituted the words "the activities of any establishment engaged wholly or mainly in".

(10) In head (vii) of sub-paragraph (e) before the words "the United Kingdom Atomic Energy Authority" there shall be inserted the words "the Post Office or".

(11) In sub-paragraph (g) the words "or the activities of any establishment of that Board engaged wholly or mainly in the repair of motor vehicle bodies" shall be omitted.

4.—(1) Paragraph 3 of the Schedule shall be amended as follows.

(2) Immediately after the definition of "office premises" there shall be inserted a new definition as follows—

"organs" means musical instruments consisting of a number of pipes supplied with wind or compressed air by means of bellows and sounded by means of keys.

(3) In the definition of "vehicle bodies" the words "invalid carriages" shall be omitted.

5.—(1) In the Appendix to the Schedule the following entries shall be substituted for the corresponding entries appearing in that Appendix—

EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order amends the Schedule to the Industrial Training (Engineering Board) Order 1968 which specifies the activities in relation to which the Engineering Industry Training Board exercises its functions.

Amongst the activities henceforth to be excluded from the engineering industry, in relation to which the Board exercises its functions, are those of establishments engaged wholly or mainly in—

- (a) the manufacture or fitting out of vehicle bodies except where the employer is a motor vehicle manufacturer or where the vehicle bodies are manufactured or fitted out to the order of a motor vehicle manufacturer ;
- (b) the repair, painting or paint spraying of vehicle bodies ;
- (c) the assembly of electric blankets.
