FOOD AND DRUGS MILK AND DAIRIES

The Milk (Great Britain) (Amendment) Order 1969

Made - - - 17th July 1969
Laid before Parliament 25th July 1969
Coming into Operation 27th July 1969

The Minister of Agriculture, Fisheries and Food and the Secretary of State, acting jointly in exercise of the powers conferred on them by sections 6 and 7 of the Emergency Laws (Re-enactments and Repeals) Act 1964(a) and of all other powers enabling them in that behalf, hereby make the following order:—

Citation and commencement

1. This order may be cited as the Milk (Great Britain) (Amendment) Order 1969, and shall come into operation on 27th July 1969.

Amendment of the principal order

- 2. The Milk (Great Britain) Order 1967(b), as amended (c), shall be further amended as follows:—
 - (a) by substituting for the proviso to article 3(1) thereof the following proviso:—

"Provided that where any milk is sold in a quantity of half a pint and the maximum price therefor in accordance with the foregoing provisions of this article would include an odd halfpenny, that maximum price shall be increased by a halfpenny.";

(b) by substituting for Schedules 1 and 2 thereto respectively Schedules 1 and 2 to this order.

Revocation

3. The Milk (Great Britain) (Amendment) Order 1968(c) is hereby revoked, but without prejudice to any proceedings in respect of any contravention of the Milk (Great Britain) Order 1967 as amended thereby.

EXPLANATORY NOTE

(This Note is not part of the order.)

This amending order, which comes into operation on 27th July 1969—

- (a) prescribes new maximum prices for milk on sales in Great Britain; and
- (b) permits the maximum price of half a pint of milk to be increased by a halfpenny if that maximum price would otherwise include an odd halfpenny.
