The Milk (Northern Ireland) (Amendment) Order 1970

<i>Made - - - -</i>	<i>23rd July 1970</i>
<i>Laid before Parliament</i>	<i>27th July 1970</i>
<i>Coming into Operation</i>	
<i>Articles 1 and 2 -</i>	<i>30th August 1970</i>
<i>Article 3 - - -</i>	<i>15th February 1971</i>

The Minister of Agriculture, Fisheries and Food in exercise of the powers conferred on him by sections 6 and 7 of the Emergency Laws (Re-enactments and Repeals) Act 1964(a) and of all other powers enabling him in that behalf, hereby makes the following order :—

Citation and commencement

1. This order may be cited as the Milk (Northern Ireland) (Amendment) Order 1970, and shall come into operation on 30th August 1970, except that article 3 hereof shall come into operation on 15th February 1971.

Amendment of the principal order

2. The Milk (Northern Ireland) Order 1965(b), as amended(c) (hereinafter referred to as “the principal order”), shall be further amended by substituting for the Schedule thereto the Schedule to this order.

3. On the day on which this article comes into operation the principal order as amended by article 2 of this order shall be further amended as follows :—

(a) by substituting for the proviso to article 3(1) thereof the following proviso :—

“Provided that where any milk is sold in a quantity of half a pint and the maximum price therefor in accordance with the foregoing provisions of this article would include an odd quarter of a new penny, that maximum price shall be increased by a quarter of a new penny.”;

(b) by substituting for the references in the Schedule thereto to 1s. 0d. and 1s. 1d. references respectively to 5p. and 5½p.

EXPLANATORY NOTE

This amending order—

- (a) prescribes new maximum prices, to come into operation on 30th August 1970, for milk on sales in Northern Ireland ; and
- (b) with effect from 15th February 1971, expresses the maximum prices in terms of decimal currency and makes a minor consequential amendment to the principal order.
