The Firearms (Variation of Fees) (Scotland) Order 1970

In exercise of the powers conferred on me by section 43 of the Firearms Act 1968(a), and of all other powers enabling me in that behalf, I hereby make the following order:—

1. This order may be cited as the Firearms (Variation of Fees) (Scotland) Order 1970 and shall come into operation on 1st January 1971.

2. Section 32(1) of the Firearms Act 1968 (which relates to the fees payable in respect of firearm and shot gun certificates), as amended by the Firearms (Variation of Fees) (Scotland) Order 1968(b), shall be amended by substituting for the words:—

- (a) “£2 10s. 0d.”, the words “£3 10s. 0d. (£3.50)”;
 - (b) “£1 5s. 0d.”, in both places where they occur, the words “£2 10s. 0d. (£2.50)”;
 - (c) “15s. 0d.”, the words “£1”; and
 - (d) “7s. 6d.”, the words “10s. 0d. (50p)”;
- and accordingly that subsection shall have effect as set out in the Schedule to this order.

Article 2

SCHEDULE

Section 32(1) of the Firearms Act 1968 as amended

32.—(1) Subject to this Act, there shall be payable—

- (a) on the grant of a firearm certificate, a fee of £3 10s. 0d. (£3.50);
 - (b) on the renewal of a firearm certificate or on the replacement of such a certificate which has been lost or destroyed, a fee of £2 10s. 0d. (£2.50);
 - (c) on any variation of a firearm certificate (otherwise than when it is renewed or replaced at the same time) so as to increase the number of firearms to which the certificate relates, a fee of £2 10s. 0d. (£2.50);
 - (d) on the grant or renewal of a shot gun certificate, a fee of £1; and
 - (e) on the replacement of a shot gun certificate which has been lost or destroyed, a fee of 10s. 0d. (50p).

EXPLANATORY NOTE

This Order increases in relation to Scotland the fees payable in respect of firearm and shot gun certificates.
