TELEGRAPHS**The Wireless Telegraphy (Broadcast Licence Charges & Exemption) Regulations 1970**

The Minister of Posts and Telecommunications, with the consent of the Treasury, in the exercise of his powers under sections 1 and 2 of the Wireless Telegraphy Act 1949(a), by the said sections as extended to the Channel Islands by the Wireless Telegraphy (Channel Islands) Order 1952(b) and by the said sections as extended to the Isle of Man by the Wireless Telegraphy (Isle of Man) Order 1952(c), and of every other power enabling him in that behalf, hereby makes the following Regulations:—

Citation and Commencement

1. These Regulations may be cited as the Wireless Telegraphy (Broadcast Licence Charges and Exemption) Regulations 1970, and shall come into operation on 1st May 1970.

Interpretation

2.—(1) In these Regulations, except so far as the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them :

“the Act” means the Wireless Telegraphy Act 1949 ;

“amateur stations” means stations for wireless telegraphy established and used, as part of the self-training of the licensee in communication by wireless telegraphy, for the purposes of communication with other stations similarly established and used ;

“authorised broadcasting stations” means stations for the time being duly authorised to conduct a broadcasting service pursuant to the International Radiocommunication Regulations for the time being in force ;

“broadcast receiving licence” means a licence to instal and use apparatus for wireless telegraphy for the purpose primarily of receiving messages sent by telephony from authorised broadcasting stations for general reception, or for the purpose primarily of receiving visual images sent by television from

such broadcasting stations for general reception, or for both of those purposes, not being either a broadcast relay station licence or a licence in respect of which the issue fee is prescribed by the Wireless Telegraphy (General Licence Charges) Regulations 1968(a) or any Regulations subsequently amending or replacing the same ;

“broadcast relay station licence” means a licence to establish and use stations for wireless telegraphy for the purpose solely or primarily of receiving programmes broadcast by authorised broadcasting stations and relaying them by wire to the premises of subscribers to the licensee’s broadcast relay service ;

“let” means let by way of either a tenancy or a licence, and either with or without board or other services or facilities ;

“licence” (except in the foregoing definition of “let”) means a wireless telegraphy licence granted under section 1 of the Act ;

“old persons’ home” means (except in the application of these Regulations to Scotland, Northern Ireland, the Channel Islands and the Isle of Man) either—

- (a) any establishment the sole or main object of which is, or is held out to be, the provision of accommodation, whether for reward or not, for retired persons of pensionable age and which—
 - (i) is provided by a local authority under section 21(1)(a) of the National Assistance Act 1948(b) ; or
 - (ii) is provided by a local health authority under section 28 of the National Health Service Act 1946(c) ; or
 - (iii) is carried on by a person who is duly registered in respect thereof under section 37 of the National Assistance Act 1948 ; or
 - (iv) is managed by any such department, authority or body as is mentioned in paragraph (f) of subsection (9) of the said section 37 ; or
 - (v) is such an establishment as is exempted from registration under the said section 37 of paragraph (g) of subsection (9) thereof ; or
- (b) a group of dwellings provided under Part V of the Housing Act 1957(d) specially for retired persons of pensionable age in association with other accommodation or facilities intended for the common use of all the occupants of the said dwellings ;

“old persons home” in the application of these Regulations to Scotland means either—

- (a) any establishment the sole or main object of which is, or is held out to be, the provision of accommodation, whether for reward or not, for retired persons of pensionable age and which—
 - (i) is provided by a local health authority under section 27 of the National Health Service (Scotland) Act 1947(e) ; or
 - (ii) is provided by a local authority under section 12 and section 59 of the Social Work (Scotland) Act 1968(f) ;

(iii) is carried on by a person who is duly registered in respect thereof under section 62 or 63 of the Social Work (Scotland) Act 1968 ; or

(iv) is an establishment the sole or main object of which is to accommodate persons for the purposes of the Social Work (Scotland) Act 1968, but where the premises or person in charge of the premises is exempt from registration under section 62 or 63 of the said Act by section 61 thereof ; or

(b) a group of dwellings provided under Part VII of the Housing (Scotland) Act 1966(a), specially for retired persons of pensionable age in association with other accommodation or facilities intended for the common use of all the occupants of the said dwellings ;

“old persons’ home” in the application of these Regulations to Northern Ireland means either—

(a) any establishment the sole or main object of which is, or is held out to be, the provision of accommodation, whether for reward or not, for retired persons of pensionable age and which—

(i) is provided by a welfare authority under section 4(1) of the Welfare Services Act (Northern Ireland) 1949(b) ; or

(ii) is provided by a local health authority under section 42 of the Health Services Act (Northern Ireland) 1948(c) ; or

(iii) is carried on by a person who is duly registered in respect thereof under section 10 of the Welfare Services (Amendment) Act (Northern Ireland) 1961(d) ; or

(iv) is managed by any such department, authority or body as is mentioned in paragraph (f) of subsection (1) of section 9 of the Welfare Services (Amendment) Act (Northern Ireland) 1961 ; or

(b) a group of dwellings provided under the Housing Acts (Northern Ireland) 1890-1967 specially for retired persons of pensionable age in association with other accommodation or facilities intended for the common use of all the occupants of the said dwellings ;

“old persons’ home” in the application of these Regulations to the Bailiwick of Jersey means a home for the time being registered under the Old Persons Homes (Registration) (Jersey) Law 1964 ;

“old persons’ home” in the application of these Regulations to the Bailiwick of Guernsey means an old persons’ home certified in writing to be such for the purposes of the Regulations by the President or Acting President of the States of Guernsey Board of Health ;

“old persons’ home” in the application of these Regulations to the Isle of Man means any establishment the sole or main object of which is, or is held out to be, the provision of accommodation, whether for reward or not, for retired persons of pensionable age and which—

(i) is provided under section 22(1) of the National Assistance (Isle of Man) Act 1951(e) ;

(ii) is provided under section 22 of the National Health Service (Isle of Man) Act 1948(f) ;

(iii) is provided under section 29 of the National Assistance (Isle of Man) Act 1951 ;

“pensionable age” (except in the application of these Regulations to Northern Ireland, the Channel Islands and the Isle of Man) has the same meaning as in the National Insurance Act 1965(a) ;

“pensionable age” in the application of these Regulations to Northern Ireland has the same meaning as in the National Insurance Act (Northern Ireland) 1966(b) ;

“pensionable age” in the application of these Regulations to the Bailiwick of Jersey has the same meaning as in the Insular Insurance (Jersey) Law 1950 ;

“pensionable age” in the application of these Regulations to the Bailiwick of Guernsey has the same meaning as in subsection (1) of section 79 of the Social Insurance (Guernsey) Law 1964 ;

“pensionable age” in the application of these Regulations to the Isle of Man has the same meaning as in the National Insurance (Isle of Man) Act 1948(c) ;

“resident” in relation to an old persons’ home, means a retired person of pensionable age who is ordinarily resident in an old persons’ home, but does not include a person in charge thereof or otherwise employed therein or a member of the family of either of them ;

and other expressions have the same meaning as they have in the Act.

(2) Any reference in these Regulations to the provisions of any enactment or Regulations shall be construed, unless the context otherwise requires, as a reference to those provisions as re-enacted or replaced by any subsequent enactment or Regulations.

(3) The Interpretation Act 1889(d) applies for the interpretation of these Regulations as it applies for the interpretation of an Act of Parliament and as if these Regulations and the Regulations hereby revoked were Acts of Parliament.

EXEMPTION FROM LICENCE

3. On and after the 1st of April 1971 there is hereby exempted from the requirement of a licence under Section 1(1) of the Act the installation or use of wireless telegraphy apparatus used only for the reception of messages sent by telephony from authorised broadcasting stations broadcasting for general reception and messages sent by telephony or telegraphy from licensed amateur stations. Provided that the person responsible for such apparatus shall ensure that the said apparatus shall be open to inspection and testing at all reasonable times by a person acting on behalf of the Minister of Posts and Telecommunications.

BROADCAST RECEIVING LICENCES

Issue Fees

4.—(1) On the issue of a broadcast receiving licence of a type and description specified in Schedule 1 the licensee shall pay an issue fee of the amount specified in relation to that type and description of licence in Schedule 1, whatever may be the duration of the licence.

(2) For the period commencing 1st May 1970 up to and including 31st March 1971 the issue fee payable in respect of a licence of the type and description specified in Schedule 2 shall be of the amount specified in relation to that type and description of licence in Schedule 2, whatever may be the duration of the licence. Provided that in calculating the amount of the said issue fee the date of issue in respect of any unlicensed period of use of apparatus of that type and description shall be deemed to be the day after the date of expiry of any licence of the same type and description last held by the licensee, save that where the said date of expiry is on or before the 31st March 1970 there shall be substituted for the figures set out in the fourth column of the first item in Schedule 2 the figures "£1 5s. 0d. (£1.25)" whatever the date of issue may be.

(3) On and after 1st April 1971 on the issue of a broadcast receiving licence of a type and description specified in Schedule 3 the licensee shall pay an issue fee of the amount specified in relation to that type and description of licence in Schedule 3, whatever may be the duration of the licence.

(4) On the issue of any other broadcast receiving licence (not being a licence of a type wholly or mainly intended to meet the needs of persons desiring to use, in a private dwelling house and without making any charge to other persons, apparatus not designed or adapted for emission as opposed to reception), the licensee shall pay an issue fee of such amount as may in the particular case appear to the Minister of Posts and Telecommunications to be proper.

Duplicate licences

5. On the issue of a duplicate of a broadcast receiving licence to which Regulations 4(1), and (2) and (3) apply and which has been lost or destroyed the licensee shall pay a fee of one shilling (£0.05).

BROADCAST RELAY STATION LICENCES

Issue Fees

6. On the issue of a broadcast relay station licence the licensee shall pay an issue fee of the amount specified in Schedule 4 in relation to licences of the type and description of that licence.

Annual Fees

7.—(1) During the continuance in force of any broadcast relay station licence, whether granted under the Act or granted under the Wireless Telegraphy Acts 1904 to 1926, the licensee shall pay on 1st August in each year an annual fee of the amount specified in Schedule 4 in relation to licences of the type and description of that licence according to the number of subscribers to the licensee's broadcast relay service who are served under the licence on the day before the fee becomes due.

(2) No royalty shall be payable under any broadcast relay station licence granted under the Wireless Telegraphy Acts 1904 to 1926 and continuing in force as aforesaid.

GENERAL

8. On the revocation or variation of a licence no part of any fee already paid or due to be paid shall be refunded or cease to be due unless the Minister of Posts and Telecommunications with the consent of the Treasury so determines.

Revocation

9. The Wireless Telegraphy (Broadcast Licence Charges) Regulations 1967(a) and the Wireless Telegraphy (Broadcast Licence Charges) Amendment (No. 1) Regulations 1968(b) and the Wireless Telegraphy (Broadcast Licence Charges) Amendment (No. 2) Regulations 1970(c) are hereby revoked.

In this Schedule, the expression "sound programmes" means programmes intended for general reception in sound only, and the expression "television programmes" means programmes intended for general reception in visual images with or without sound.

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

These Regulations replace the Wireless Telegraphy (Broadcast Licence Charges) Regulations 1967, the Wireless Telegraphy (Broadcast Licence Charges) Amendment (No. 1) Regulations 1968 and the Wireless Telegraphy (Broadcast Licence Charges) Amendment (No. 2) Regulations 1970 providing for the fees payable on the issue of sound and television broadcast receiving licences and broadcast relay station licences. Regulation 3 exempts from 1st April 1971 the requirement of a licence for the installation and use of apparatus for receiving sound broadcasts from authorised broadcasting stations broadcasting for general reception and Schedule 2 contains a sliding scale of fees payable on the issue of sound broadcast receiving licences during the period prior to 1st April 1971. They include a revised interpretation of the expression "old persons' home" in the application of the Regulations to Scotland, Northern Ireland, the Isle of Man and the Channel Islands and of the expression "pensionable age" in the application of the Regulations to Scotland, Northern Ireland, the Isle of Man and the Channel Islands.
