The Secretary of State, in exercise of the powers conferred on him by section 170(2) and (4) of the Industrial Relations Act 1971(a) and of all other powers enabling him in that behalf, hereby makes the following Order:—

1. This Order may be cited as the Industrial Relations Act 1971 (Commencement No. 2) Order 1971.
2. The provisions of the Industrial Relations Act 1971 specified in the Schedule to this Order shall come into force on 1st November 1971.
3. Where any matter is referred to the Commission on Industrial Relations under section 121(1) of the Industrial Relations Act 1971, which was referred to the Royal Commission on Industrial Relations by the Secretary of State before the coming into operation of this Order, anything which was in the process of being done by or in relation to the Royal Commission on Industrial Relations in connection with the reference to it may be continued by or in relation to the Commission on Industrial Relations in connection with the reference under the said section 121(1).
