## The Statutory Instruments (Amendment) Regulations 1972

<i>Made</i>	- - -	<i>7th August 1972</i>
<i>Laid before Parliament</i>		<i>9th August 1972</i>

The Minister for the Civil Service, in exercise of the powers conferred by section 8(1) of the Statutory Instruments Act 1946(a) and now vested in him (b) and of all other powers enabling him in that behalf, and with the concurrence of the Lord Chancellor and the Speaker of the House of Commons, hereby makes the following Regulations:—

1. These Regulations may be cited as the Statutory Instruments (Amendment) Regulations 1972, and shall come into operation on 30th August 1972.

2. The Interpretation Act 1889(c) shall apply for the interpretation of these Regulations as it applies for the interpretation of an Act of Parliament.

3. The Statutory Instruments Regulations 1947(d) shall be amended by substituting for the proviso to Regulation 10(1)(a) the following proviso:—

“Provided that copies of—

- (i) instruments which have ceased to be in operation at the time of the completion of the annual edition,
- (ii) local instruments, and
- (iii) Orders in Council under section 1(3) of the Northern Ireland (Temporary Provisions) Act 1972(e),

may be omitted;”.
