RATING AND VALUATION

The Valuation Timetable (Scotland) Order 1972

Made - - - - 9th October 1972

Coming into Operation 10th October 1972

In exercise of the powers conferred on me by section 13(1) and section 42(1) of the Valuation and Rating (Scotland) Act 1956(a) and section 22(d) of the Local Government (Financial Provisions) (Scotland) Act 1963(b), and of all other powers enabling me in that behalf, I hereby make the following order:—

1. This order may be cited as the Valuation Timetable (Scotland) Order 1972 and shall come into operation on 10th October 1972.

2. The Interpretation Act 1889(c) shall apply for the interpretation of this order as it applies for the interpretation of an Act of Parliament.

3. The provisions of Schedule 2 to the Valuation and Rating (Scotland) Act 1956 as amended (d) shall be further amended as follows:—

(a) In Part I in relation to the last date for the disposal of appeals and complaints, for the words “16th October in the following year” in the second column thereof there shall be substituted the words “31st March in the following year”;

(b) In Part II in relation to the last date for the disposal of appeals and complaints for the words “30th November” in the second column thereof, there shall be substituted the words “31st March”;

(c) In Part III for the words—

“Final date for the disposal of appeals and complaints . . . 16th October” there shall be substituted the words—

“Final date for the disposal of appeals and complaints in Years of Revaluation . . . 31st March in the following year.

Final date for disposal of appeals and complaints for other years . . . 15th May”.

4. The Valuation Timetable (Scotland) (No. 2) Order 1967(a) is hereby revoked.

EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order amends Schedule 2 to the Valuation and Rating (Scotland) Act 1956 which contains the Valuation timetable. For years of revaluation it postpones from 16th October in the following valuation year to 31st March in that year, the last date for disposal by Valuation Appeal Committees of appeals and complaints against entries in both the ordinary and supplementary valuation rolls. It also postpones from 30th November to 31st March the last date for disposal by Valuation Appeal Committees of appeals and complaints against entries in the ordinary roll for other years. The Order also revokes the Valuation Timetable (Scotland) (No. 2) Order 1967.
