The Goods Vehicles (Plating and Testing) (Amendment) (No. 2) **Regulations 1972**

Made	23rd May 1972
Laid before Parliament	6th June 1972
Coming into Operation	27th June 1972

The Secretary of State for the Environment, in exercise of his powers under section 9(1) and (6) of the Road Safety Act 1967(a) as amended by section 148 of the Transport Act 1968(b) and of all other enabling powers, and after consultation with representative organisations in accordance with the provisions of section 260(2) of the Road Traffic Act 1960(c), as applied by section 29(6) of the said Act of 1967, hereby makes the following Regulations:—

- 1.—(1) These Regulations shall come into operation on 27th June 1972 and may be cited as the Goods Vehicles (Plating and Testing) (Amendment) (No. 2) Regulations 1972.
- (2) The Interpretation Act 1889(d) shall apply for the interpretation of these Regulations as it applies for the interpretation of an Act of Parliament.
- 2. The Goods Vehicles (Plating and Testing) Regulations 1971(e), as amended (f), shall have effect as though—
 - (1) in Regulation 16(a)—
 - (a) in sub-paragraph (i) for the words "Regulation 71 of the Construction and Use Regulations" there were substituted the words "Regulation 71, 74A, 74D or 74E of the Construction and Use Regulations as amended by the Motor Vehicles (Construction and Use) (Amendment) Regulations 1972(g);";
 - (b) for sub-paragraphs (ii), (iii) and (iv) there were substituted the following sub-paragraphs-
 - "(ii) a trailer liable to be used in contravention of Regulation 72, 74A, 74D or 74E of the said Regulations; or
 - (iii) a motor vehicle or trailer liable to be used in contravention of Regulation 74B, 75 or 125 of the said Regulations,";

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

These Regulations further amend the Goods Vehicles (Plating and Testing) Regulations 1971 by providing that, when determining the plated weights for goods vehicles, goods vehicle examiners shall have regard to additional Regulations now contained in the Motor Vehicles (Construction and Use) Regulations 1969 (S.I. 1969/321).
