FOOD AND DRUGS**COMPOSITION****The Lead in Food (Amendment) Regulations 1973**

The Minister of Agriculture, Fisheries and Food and the Secretary of State for Social Services, acting jointly, in exercise of the powers conferred on them by sections 4 and 123 of the Food and Drugs Act 1955(a), as read with the Secretary of State for Social Services Order 1968(b), and of all other powers enabling them in that behalf, hereby make the following regulations after consultation with such organisations as appear to them to be representative of interests substantially affected by the regulations:—

Citation, commencement and interpretation

1.—(1) These regulations may be cited as the Lead in Food (Amendment) Regulations 1973, and shall come into operation on 14th July 1973.

(2) The Interpretation Act 1889(c) shall apply to the interpretation of these regulations as it applies to the interpretation of an Act of Parliament.

Amendment of principal regulations

2. The Lead in Food Regulations 1961(d), as amended(e), shall be further amended by substituting for paragraph (4) of regulation 3 thereof the following paragraph:—

“(4) The foregoing provisions of this regulation shall not apply to any food in respect of which the maximum permitted lead content is prescribed by any regulations, other than these regulations or any amendment to these regulations, made under the Food and Drugs Act 1955 or by any order, other than the Food Standards (Edible Gelatine) Order 1951(f), as amended(g), having effect as if contained in regulations so made.”.

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

These Regulations, which come into operation on 14th July 1973, amend the Lead in Food Regulations 1961 as amended by the Colouring Matter in Food Regulations 1966 (S.I. 1966/1203). They extend exemption from the lead limits specified by the principal regulations, to food (other than edible gelatine) for which the maximum permitted lead limit is prescribed by any other instrument made, or having effect as if made, under the Food and Drugs Act 1955.
