EXCHANGE CONTROL**The Exchange Control (Authorised Dealers and Depositaries)
(No. 2) Order 1973***Made* - - - 20th November 1973*Coming into Operation* 20th December 1973

The Treasury, in exercise of the powers conferred upon them by sections 42(1) and 36(5) of the Exchange Control Act 1947(a), hereby make the following Order:—

1.—(1) This Order may be cited as the Exchange Control (Authorised Dealers and Depositaries) (No. 2) Order 1973, and shall come into operation on 20th December 1973.

(2) In this Order, notwithstanding section 43(2) of the Exchange Control Act 1947 (which provides that references to the United Kingdom in that Act shall be construed as if the Isle of Man were part of the United Kingdom) and notwithstanding section 31 of the Interpretation Act 1889(b), the expression “the United Kingdom” does not include the Isle of Man.

(3) The Interpretation Act 1889 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

2. Offices in the United Kingdom, the Channel Islands or the Isle of Man of the persons specified in Schedule 1 to this Order are authorised to act for the purposes of the said Act as authorised dealers in relation to gold.

3. The following are authorised to act for the purposes of the said Act as authorised dealers in relation to gold and all foreign currencies:—

(a) offices in the United Kingdom, the Channel Islands or the Isle of Man of the persons specified in paragraph 1 of Schedule 2 to this Order;

(b) offices in the United Kingdom of the persons specified in paragraph 2 of Schedule 2 to this Order, and

(c) the Head Office of United Dominions Trust Ltd.

4. The following are authorised to act as authorised depositaries for the purposes of Part III of the said Act:—

(a) the Bank of England, and the Quotations Department and the Official Assignee of The Stock Exchange; and

(b) the persons and offices specified in Schedule 3 to this Order.

5. The Orders specified in Schedule 4 to this Order are hereby revoked.

6. This Order shall extend to the Channel Islands, and any reference in this Order to the Exchange Control Act 1947 includes a reference to that Act as extended by the Exchange Control (Channel Islands) Order 1947(a).

EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order, which supersedes (with amendments) the Exchange Control (Authorised Dealers and Depositaries) Order 1973, as amended, lists:—

- (a) the banks and other persons authorised under the Exchange Control Act 1947 to deal in gold and foreign currencies; and
- (b) those who are entitled to act as authorised depositaries for the purpose of the deposit of securities as required by that Act.

The main change relates to the banks which were listed in Schedule 2 to that Order, under which any office opened by any of those banks in the Channel Islands or the Isle of Man automatically became an authorised dealer in gold and foreign currency and an authorised depositary. Now any office opened in the Channel Islands or the Isle of Man by the banks listed in paragraph 2 of Schedule 2 to the new Order becomes an authorised depositary, but it does not become an authorised dealer in gold or foreign currency.
