The Provision of Milk and Meals (Amendment)
Regulations 1974

The Secretary of State for Education and Science and the Secretary of State for Wales, in joint exercise of the powers conferred by section 49 of the Education Act 1944^(a) as amended by section 1 of the Education (Milk) Act 1971^(b) and vested in them^(c), hereby make the following regulations:—

Citation, commencement and interpretation

1.—(1) These regulations may be cited as the Provision of Milk and Meals (Amendment) Regulations 1974 and these regulations and the Provision of Milk and Meals Regulations 1969 to 1973 may be cited together as the Provision of Milk and Meals Regulations 1969 to 1974.

(2) These regulations shall come into operation on 1st August 1974.

(3) The Interpretation Act 1889^(d) shall apply for the interpretation of these regulations as it applies for the interpretation of an Act of Parliament.

Organisers of school meals

2. Regulation 8 of the Provision of Milk and Meals Regulations 1969^(e), which has ceased to have effect by virtue of section 112(3) of the Local Government Act 1972^(f), is hereby revoked.

Determination of financial hardship

3. Schedule 1 to the Provision of Milk and Meals Regulations 1969 as amended^(g) shall have effect subject to the substitution for the table and the first note in paragraph 1 (net income scale) of the following table and note.

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

These Regulations amend the provisions for the calculation of a parent's income for the purpose of determining his entitlement to remission of the charge for school dinners provided in county and voluntary schools. They also revoke the provision requiring the local education authority to appoint an organiser of school meals, since this provision has ceased to have effect by virtue of section 112(3) of the Local Government Act 1972.
