The Remuneration of Teachers (Primary and Secondary Schools) (Amendment No. 3) Order 1974

Made - - -

7th October 1974

Coming into Operation

8th October 1974

Whereas-

- (1) in pursuance of section 2(2) of the Remuneration of Teachers Act 1965(a) ("the Act") the Committee constituted under section 1 thereof for the purpose of considering the remuneration payable to teachers in primary and secondary schools maintained by local education authorities ("the Committee") have transmitted to the Secretary of State for Education and Science ("the Secretary of State") recommendations agreed on by them with respect to the remuneration of such teachers;
- (2) there are in force Orders made under section 2 of the Act with respect to the remuneration of teachers in primary and secondary schools maintained by local education authorities, namely, the Remuneration of Teachers (Primary and Secondary Schools) Order 1973(b), the Remuneration of Teachers (Primary and Secondary Schools) (Amendment) Order 1974(c) and the Remuneration of Teachers (Primary and Secondary Schools) (Amendment No. 2) Order 1974(d);
- (3) it appears to the Secretary of State that effect can more conveniently be given to the recommendations of the Committee by amending the scales and other provisions set out in the document referred to in the said Orders, namely, the document published by Her Majesty's Stationery Office on 24th May 1973 under the title "SCALES OF SALARIES FOR TEACHERS IN PRIMARY AND SECONDARY SCHOOLS, ENGLAND AND WALES, 1973" ("the Document");
- (4) in pursuance of section 2(5) of the Act the Secretary of State has prepared a draft Order (being the draft of this Order) setting out the amendments of the scales and other provisions which, in his opinion, are requisite for giving effect to the recommendations of the Committee; and
- (5) the Secretary of State, as required by section 2(6) of the Act, has consulted the Committee with respect to the draft Order and the Committee have made no representations with respect thereto.

Now, therefore, the Secretary of State, in pursuance of section 2(6) of the Act, hereby orders as follows:—

Citation and Commencement

1. This Order may be cited as the Remuneration of Teachers (Primary and Secondary Schools) (Amendment No. 3) Order 1974 and shall come into operation on 8th October 1974.

Interpretation

2. The Interpretation Act 1889(a) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

Amendment of Document

3.—(1) For section 13 of Part IV of the Document there shall be substituted the following section—

"13. LONDON AREA PAYMENT

Teachers serving in the London Area shall receive additional payment as follows:—

- (1) At the rate of £351 per annum with effect from 1st March 1974 to teachers serving in the Inner Area.
- (2) At the rate of £267 per annum with effect from 1st March 1974 to teachers—
 - (a) serving in the Outer Area; or
 - (b) who (i) prior to 1st October 1974 were employed, or are employed on or after that date in pursuance of an appointment made before it, in a school maintained by a local education authority in an area outside Greater London but within the Metropolitan Police District, or
 - (ii) on 31st March 1969 were employed and have remained in such a school in an area which on that date was, but subsequently ceased to be, part of that District

for so long only as they remain in teaching service in such an area

- (3) At the rate of £141 per annum with effect from 1st April 1974 to teachers serving in the Fringe Area and not in receipt of London Area Payment under sub-section (2)(b) above.
- (4) Teachers normally serving in the London Area but temporarily employed elsewhere shall continue to receive London Area payment at the rate appropriate to their normal area of employment.
- (5) For the purpose of this section—

"the Inner Area" means the area of the Inner London Education Authority and of the London Boroughs of Barking, Brent, Ealing, Haringey, Merton and Newham;

"the Outer Area" means Greater London, excluding the Inner Area;

"the Fringe Area" means-

Berkshire: the Districts of Bracknell, Slough, Windsor and Maidenhead;

Buckinghamshire: the Districts of Beaconsfield and Chiltern;

Essex: the Districts of Basildon, Brentwood, Epping Forest, Harlow, Thurrock;

Hertfordshire: the Districts of Broxbourne, Dacorum, East Herts, Hertsmere, St. Albans, Three Rivers, Watford, Welwyn Hatfield;

Kent: the Districts of Dartford and Sevenoaks;

Surrey: the whole County;

West Sussex: the District of Crawley;

"the London Area" comprises the Inner Area, the Outer Area and the Fringe Area."

(2) In Part V of the Document there shall be added immediately after section 20 (Divided Service) the following section—

"20A. With effect from 1st September 1974, a teacher to whom there is assigned the duties of teacher-tutor under the pilot scheme approved by the Burnham Committee for the induction of new entrants to the teaching profession of either the Liverpool Local Education Authority or the North-umberland Local Education Authority, shall receive additional allowance, not exceeding £288, in accordance with the provisions of the relevant scheme."

EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order, which gives effect to the recommendations agreed on by the Committee for the consideration of the remuneration of teachers in primary and secondary schools, as regards such teachers makes provision for—

- (a) improvements in the "London Area" payment, and extends the area to which such payment relates; and
- (b) the payment of additional allowance to teachers who under the pilot schemes of the Liverpool and Northumberland local education authorities are responsible for the induction of new entrants to the teaching profession.

The Order has retrospective effect by virtue of section 7(3) of the Remuneration of Teachers Act 1965.
