ACQUISITION OF LAND

**The County Council of the County of Zetland (Calback Ness)  
Compulsory Purchase Order Confirmation Order 1974**

In exercise of the powers conferred on me by Paragraph 3 as read with Paragraph 7 of Schedule 2 to the Zetland County Council Act 1974<sup>(a)</sup> and of all other powers enabling me in that behalf, I hereby make the following order:—

1.—(1) This order may be cited as the County Council of the County of Zetland (Calback Ness) Compulsory Purchase Order Confirmation Order 1974 and shall come into operation on 19th November 1974.

(2) The Interpretation Act 1889<sup>(b)</sup> shall apply for the interpretation of this order as it applies for the interpretation of an Act of Parliament.

2. The County Council of the County of Zetland (Calback Ness) Compulsory Purchase Order 1974 as set forth in the Schedule to this Order, which provides for the compulsory acquisition of certain land in the district of Delting extending to 925 acres or thereby being part of the land subject to compulsory acquisition described in Schedule 3 to the said Act of 1974, is hereby confirmed.

## SCHEDULE

*The provisions of the County Council of the County of Zetland (Calback Ness) Compulsory Purchase Order 1974 are as follows:—*

### THE ZETLAND COUNTY COUNCIL ACT 1974

The County Council of the County of Zetland hereby make the following order:—

1. Subject to the provisions of this Order the said County Council of the County of Zetland are, under section 24 of the Zetland County Council Act 1974, hereby authorised to purchase compulsorily for the purposes of that Act, the areas of ground which are described in the Schedule hereto and coloured green and hatched red and numbered "1" and "2" on the map prepared in duplicate, signed and sealed with reference to this order and marked "Plan referred to in the County Council of the County of Zetland (Calback Ness) Compulsory Purchase Order 1974". One duplicate of the map is deposited in the offices of the said County Council of the County of Zetland and the other is deposited in the offices of the Secretary of State for Scotland.

2. The Interpretation Act 1889 applies to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.

3. This Order may be cited as the County Council of the County of Zetland (Calback Ness) Compulsory Purchase Order 1974.

4. In the case of any discrepancy between the acreage indicated in the Schedule hereto for each area and the actual acreage of the areas coloured green and hatched red and numbered "1" and "2" on the Plan signed as relative hereto, the plan shall prevail.
