**The Removal and Disposal of Vehicles (Amendment)
Regulations 1974**

The Secretary of State for the Environment (as respects England), the Secretary of State for Scotland (as respects Scotland) and the Secretary of State for Wales (as respects Wales) in exercise of the powers conferred by sections 21(4) and 22(1) of the Civic Amenities Act 1967^(a) and sections 52(1) and 53(3) of the Road Traffic Regulation Act 1967^(b), as altered by the Removal and Disposal of Vehicles (Alteration of Enactments) Order 1967^(c), and now vested in them ^(d), after consultation with representative organisations in accordance with the provisions of section 107(2) of the Road Traffic Regulation Act 1967, and in exercise of all other enabling powers, hereby make the following Regulations:—

1. These Regulations may be cited as the Removal and Disposal of Vehicles (Amendment) Regulations 1974 and shall come into operation on 3rd December 1974.

2. The Removal and Disposal of Vehicles Regulations 1968^(e) shall be amended so as to have effect in accordance with the following provisions of these Regulations.

3. In Regulation 17 (Charge for removing vehicles), in paragraph (1)—

- (a) for the words “£5 plus 5s.” there shall be substituted the words “£7.50 plus 35p”;
- (b) after the words “City of London” there shall be inserted the word “or”;
- (c) for the words “or the City of Birmingham, £4 10s. 0d.” there shall be substituted the words, “£7”; and
- (d) for the words “£4” there shall be substituted the words “£6.50.”.

4. In Regulation 18 (Charge for storing vehicles), in paragraph (1), for the words "10s." there shall be substituted the words "£1".

5. In Regulation 19 (Charge for disposing of vehicles), for the words "£2" there shall be substituted the words "£3".

EXPLANATORY NOTE

These Regulations amend the Removal and Disposal of Vehicles Regulations 1968 by increasing the charges payable for the removal, storage and disposal of vehicles prescribed by those Regulations in respect of vehicles removed pursuant to those Regulations or to section 20 of the Civic Amenities Act 1967.
