NATIONAL HEALTH SERVICE, ENGLAND AND WALES

The National Health Service (Transfer of Local Health Authority Trust Property) Order 1974*Made* - - - - 19th February 1974*Laid before Parliament* 6th March 1974*Coming into Operation* 1st April 1974

The Secretary of State for Social Services, as respects England, and the Secretary of State for Wales, as respects Wales, in exercise of the powers conferred on them by section 25(1) of the National Health Service Reorganisation Act 1973^(a) and of all other powers enabling them in that behalf, hereby make the following Order:—

Citation and commencement

1. This Order may be cited as the National Health Service (Transfer of Local Health Authority Trust Property) Order 1974 and shall come into operation on 1st April 1974.

Transfer of Trust Property held for health purposes by local health authorities

2. Any property held immediately before 1st April 1974 by a local health authority specified in Column 1 of the Schedules to this Order on trust for purposes which are wholly or mainly the same as those of any part of the health service shall on 1st April 1974 be transferred to and vest in such one or more health authorities as are specified in Column 2 of the Schedules.
