**The Rate Support Grant (Increase) (Scotland) (No. 2)
Order 1974**

Made - - - - - 12th March 1974

House of Parliament 19th March 1974*

Coming into Operation 27th March 1974

In exercise of the powers conferred on me by section 4 of the Local Government (Scotland) Act 1966(a) and subsections (7), (8) and (9) of section 60 of the National Health Service (Scotland) Act 1972(b) and of all other powers enabling me in that behalf, since it appears to me that there has been an unforeseen increase in the level of prices, costs and remuneration affecting substantially the reckonable expenditure of local authorities for the year 1973-74, with the consent of the Treasury and after consultation with such associations of local authorities as appear to me to be concerned in accordance with the provisions of section 3 of the Act, I hereby make the following order:—

Title, commencement and interpretation.

1.—(1) This order may be cited as the Rate Support Grant (Increase) (Scotland) (No. 2) Order 1974 and shall come into operation on the day following the day on which it is approved by a resolution of the Commons House of Parliament.

(2) The Interpretation Act 1889(c) shall apply for the interpretation of this order as it applies for the interpretation of an Act of Parliament.

(3) In this order “the Act” means the Local Government (Scotland) Act 1966.
