CUSTOMS AND EXCISE

The Import Duties (Egypt) (Reductions) Order 1975*Made* - - - - - 8th December 1975*Laid before the House of Commons* 11th December 1975*Coming into Operation* - - - 1st January 1976

The Lords Commissioners of Her Majesty's Treasury, by virtue of the powers conferred on them by sections 1, 3(6) and 13 of the Import Duties Act 1958(a), as amended by section 5(5) of, and paragraph 1 of Schedule 4 to, the European Communities Act 1972(b), and of all other powers enabling them in that behalf, on the recommendation of the Secretary of State(c), hereby make the following Order:—

1.—(1) This Order may be cited as the Import Duties (Egypt) (Reductions) Order 1975 and shall come into operation on 1st January 1976.

(2) In this Order—

references to goods originating in Egypt are references to goods which

- (a) are to be regarded under the Agreement, signed on 18th December 1972, between the European Economic Community and Egypt(d) as originating in Egypt or,
- (b) being products of a class excluded from the scope of the Protocol to the said Agreement relating to origin of goods, are nevertheless goods of Egypt;

references to a heading or subheading are references to a heading or subheading of the Customs Tariff 1959;

“the M rate” in relation to goods of any heading or subheading means the rate which is shown in relation to such goods prefixed by the letter “M” in column 4 of Schedule 1 to the Import Duties (General) (No. 5) Order 1975(e) (being the rate applicable to goods satisfying the requisite conditions to benefit from the eventual abolition of customs duties in trade between member States of the European Economic Community) except that the M rate in column 2 of Part II of Schedule 2 hereto shall be taken as being nil in relation to any products there referred to if they are of a description specified in column 2 of Parts II or III of Schedule 2 to the said Order;

the abbreviations used in Schedule 2 hereto (being those used in the Customs Tariff 1959) have the meanings given in Article 11(5) of the said Order, except that the abbreviation “w.i.g.”, when applied to more than two rates of duty, means “whichever is the greatest”.

(3) The Interpretation Act 1889^(a) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

2.—(1) Any import duty for the time being chargeable on goods which fall within the subheading specified in column 1 of Part I of Schedule 1 hereto and are of the description specified in column 2 thereof shall be charged at the M rate instead of any higher rate which would otherwise apply in the case of goods originating in Egypt.

(2) Any import duty for the time being chargeable on goods which fall within a heading or subheading specified in Part II of Schedule 1 hereto shall be charged at the M rate instead of any higher rate which would otherwise apply in the case of goods originating in Egypt.

3.—(1) Subject to Article 4(1) below, any import duty for the time being chargeable on goods which fall within a subheading specified in column 1 of Part I of Schedule 2 hereto and are of a description specified in column 2 thereof shall be charged at the rate specified in column 3 thereof in relation to the goods instead of any higher rate which would otherwise apply in the case of goods originating in Egypt.

(2) Any import duty for the time being chargeable on goods which fall within a heading or subheading specified in column 1 of Part II of Schedule 2 hereto shall be charged at the rate specified in column 2 thereof in relation to the heading or subheading instead of any higher rate which would otherwise apply in the case of goods originating in Egypt.

4.—(1) Where a period of time is specified in column 2 of Part I of Schedule 2 hereto in relation to any subheading, the reductions in duty provided for in relation to that subheading shall apply only during that period.

(2) Any description of goods in column 2 of Part I of Schedule 1 or 2 to this Order shall be taken to comprise all goods which would be classified under an entry in the same terms constituting a subheading in the relevant heading of the Customs Tariff 1959.

5. Articles 2 and 3 above shall operate without prejudice to any greater reductions in, or to any exemption from, import duties which may be available in the case of goods originating in Egypt apart from this Order by virtue of their being goods of a developing country or otherwise.

6. Where any import duty for the time being chargeable on any goods has been reduced by a directly applicable Community provision the import duty shall, to the extent of that reduction, not be regarded as reduced by virtue of this Order and the reference to it in the Schedules hereto shall be treated as merely indicative of the rate of import duty payable in respect of the goods.

EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order, which comes into operation on 1st January 1976, implements obligations of the United Kingdom, concerning import duties after the end of 1975, in respect of goods of Egypt under the Agreement of 18th December 1972 between the European Economic Community (EEC) and Egypt.

In the case of goods specified in Schedule 1, the rate of import duty is reduced to the same as that chargeable on goods satisfying the requisite conditions to benefit from the eventual abolition of customs duties between member States of the EEC. This is the rate prefixed by the letter "M" in column 4 of Schedule 1 to the Import Duties (General) (No. 5) Order 1975 (which sets out the United Kingdom Customs Tariff). In the case of goods of a tariff heading or subheading specified in Schedule 2, import duty is reduced to the rates specifically set out in column 2 or 3 of that Schedule. The reductions in duty made by this Order do not affect any entitlement to a greater reduction in, or any exemption from, duty which may be available in the case of goods of Egypt as goods of a developing country under the Generalised System of Preferences of the EEC.
