MARRIAGES, ETC.**
**The Registration of Births, Deaths and Marriages (Adopted  
Children Register) (Scotland) Regulations 1975**

<i>Made</i> - - - - -	9th December 1975
<i>Laid before Parliament</i>	19th December 1975
<i>Coming into Operation</i>	1st January 1976

In exercise of the powers conferred upon me by sections 23(1) and 56(3) of the Adoption Act 1958 (a) as amended by paragraphs 25 and 38 of Schedule 3 to the Children Act 1975 (b), and with the approval of the Secretary of State for Scotland, I hereby make the following regulations:—

*Citation, Commencement and Interpretation*

**1.**—(1) These regulations may be cited as the Registration of Births, Deaths and Marriages (Adopted Children Register) (Scotland) Regulations 1975 and shall come into operation on 1st January 1976.

(2) The Interpretation Act 1889 (c) shall apply for the interpretation of these regulations as it applies for the interpretation of an Act of Parliament.

*Form of Entry in Adopted Children Register*

**2.** The form of entry shall be as set out in the Schedule to these regulations.

*Revocation*

**3.** The Registration of Births, Deaths and Marriages (Adopted Children Register) (Scotland) Regulations 1971 (d) are hereby revoked.
