RATING AND VALUATION

The Rate Rebate (Scotland) Amendment Regulations 1975

Made -11th March 1975 Laid before Parliament 17th March 1975 Coming into Operation 6th April 1975

In exercise of the powers conferred on me by sections 112 and 233(2) of the Local Government (Scotland) Act 1973(a) and of all other powers enabling me in that behalf I hereby, with the consent of the Treasury, make the following regulations:-

Citation and commencement

1. These regulations may be cited as the Rate Rebate (Scotland) Amendment Regulations 1975 and shall come into operation on 6th April 1975.

Interpretation

- 2.—(1) The Interpretation Act 1889(b) shall apply for the interpretation of these regulations as it applies for the interpretation of an Act of Parliament.
- (2) References in these regulations to any enactment shall be construed as including references to such enactment as amended or extended by or under any other enactment, order or regulations.
- (3) In these regulations "the principal regulations" means the Rate Rebate (Scotland) Regulations 1974(c) and other words and expressions have the same meaning as in the principal regulations.

Amendment of principal regulations

- 3. For the purposes of rebate for any week in a rebate period being a week commencing after 6th April 1975:-
 - (a) for "£2.15" in regulation 17 of the principal regulations there shall be substituted "£2.50";
 - (b) for Schedule 1 to the principal regulations, as amended by regulation 3 of the Rate Rebate (Scotland) Amendment Regulations 1974(d), there shall be substituted Schedule 1 to these regulations.

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

These Regulations prescribe, for any week of a rebate period being a week commencing after 6th April 1975, (a) a revised maximum amount which may be granted for rate rebate, and (b) an increase in the scale of needs allowances, by reference to which rate rebate is calculated. The amounts of the needs allowances were last increased by Regulation 3 of the Rate Rebate (Scotland) Amendment Regulations 1974.
