**The Road Vehicles (Registration and Licensing) (Amendment)
Regulations 1976**

The Secretary of State for Transport in exercise of the powers conferred by sections 12, 16, 23 (as modified by section 39(1) and paragraph 20 of Part I of Schedule 7) and 37 of the Vehicles (Excise) Act 1971(a), and of all other enabling powers, and in the case of Regulations 3, 4 and 6 with the approval of the Treasury, hereby makes the following Regulations:—

1. These Regulations shall come into operation on 9th November 1976 and may be cited as the Road Vehicles (Registration and Licensing) (Amendment) Regulations 1976.

2. The Road Vehicles (Registration and Licensing) Regulations 1971(b), as amended (c), shall be further amended so as to have effect in accordance with the following provisions of these Regulations.

3. In Regulation 6 (Application for duplicate licence or registration book), in paragraph (1), for the words “25p” there shall be substituted the words “£2”.

4. In Regulation 15 (Notification of registration and licensing particulars), in paragraph (1) for the words “25p” there shall be substituted the words “£2”.

5. In Regulation 16 (Exhibition of licences), in paragraph (3), in subparagraph (c) the words “lower corner” shall be deleted.

6. In Regulation 31 (Issue of trade plates and replacements therefor), in paragraph (3) for the words from “of 90p” to “£1.35 in any other case” there shall be substituted the words “, where the plate is one of two replaced at the same time, of £3.25 in respect of each plate, or, where the plate is not one of two so replaced—

(c) There are no relevant amending Instruments.

- (i) a fee of £5.50 in respect of a plate containing means whereby the licence may be fixed thereto, or
- (ii) a fee of £4 in any other case.”.

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

These Regulations amend the Road Vehicles (Registration and Licensing) Regulations 1971 as amended. The effect of the amendments is—

- (1) to increase the fee for—
 - (a) a duplicate licence or registration book from 25p to £2 (Regulation 3);
 - (b) the notification of registration and licensing particulars from 25p to £2 (Regulation 4);
 - (c) the issue of replacements for trade plates to £3.25 for each plate where both are replaced, £5.50 for a front plate (with licence holder), or £4 for the rear plate (Regulation 6); and
- (2) to modify the requirement as to the display of licences in Regulation 16(3)(c) (Regulation 5).
