## LEGAL AID AND ADVICE, SCOTLAND

Act of Sederunt (Legal Aid Rules and Legal Aid Fees  
Amendment) 1976

Made - - - 5th March 1976

Coming into Operation 30th March 1976

The Lords of Council and Session, under and by virtue of the powers conferred upon them by section 16 of the Legal Aid (Scotland) Act 1967(a), and of all other powers competent to them in that behalf, do hereby enact and declare:

*Citation, commencement and interpretation*

1.—(1) This Act of Sederunt may be cited as the Act of Sederunt (Legal Aid Rules and Legal Aid Fees Amendment) 1976 and shall come into operation on 30th March 1976.

(2) The Interpretation Act 1889(b) shall apply for the interpretation of this Act of Sederunt as it applies for the interpretation of an Act of Parliament.

*Legal aid in proceedings before the Employment Appeal Tribunal*

2. The Act of Sederunt (Legal Aid Rules) 1958(c), as amended(d), is further amended—

- (a) in rule 2(1), by substituting for sub-paragraph (i) the following sub-paragraph:—  
“ (i) proceedings before the Employment Appeal Tribunal;”;
- (b) in rule 4(2), by inserting after the words “the Lands Tribunal for Scotland” the words “or the Employment Appeal Tribunal;”;
- (c) in rule 5(2), by inserting after the words “the Lands Tribunal for Scotland,” the words “or the registrar of the Employment Appeal Tribunal;”.

*Fees in proceedings before the Employment Appeal Tribunal*

3. The Act of Sederunt (Legal Aid Fees) 1971(e), as amended(f), is further amended in rules 1, 2A and 4A, by substituting for the words “the National Industrial Relations Court” the words “the Employment Appeal Tribunal”.

And the Lords Appoint this Act of Sederunt to be inserted in the Books of Sederunt.
