The Lords of Council and Session, under and by virtue of the powers conferred upon them by section 16 of the Administration of Justice (Scotland) Act 1933^(a) and section 32 of the Sheriff Courts (Scotland) Act 1971^(b), and of all other powers competent to them in that behalf, do hereby enact and declare:—

Citation, interpretation and commencement

1.—(1) This Act of Sederunt may be cited as the Act of Sederunt (Transfer of Functions Amendments) 1976 and shall come into operation on 15th April 1976.

(2) The Interpretation Act 1889^(c) shall apply for the interpretation of this Act of Sederunt as it applies for the interpretation of an Act of Parliament.

Amendments consequential on transfer of functions

2. In consequence of the transfer of functions from the Treasury to the Secretary of State effected by Article 2 of the Transfer of Functions (Treasury and Secretary of State) Order 1974^(d), in the Acts of Sederunt and rules specified in the Schedule to this Act of Sederunt, for the words “the Queen’s and Lord Treasurer’s Remembrancer”, wherever they occur, there shall be substituted . . . the words “the Secretary of State”.

And the Lords appoint this Act of Sederunt to be inserted in the Books of Sederunt.
