The Gaming Act (Variation of Fees) Order 1976

In pursuance of sections 48(5) and 51(4) of the Gaming Act 1968(a), I hereby make the following Order:—

1.—(1) This Order may be cited as the Gaming Act (Variation of Fees) Order 1976 and shall come into operation on 1st May 1976.

(2) This Order shall not extend to Scotland.

2. The Interpretation Act 1889(b) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

3. The provisions of section 48 of the Gaming Act 1968 specified in the first column of the Schedule to this Order (which relate to fees charged in respect of the matters mentioned in the second column of that Schedule) shall have effect as if, for the references to the sums specified in those provisions (for which the sums mentioned in the third column of that Schedule were substituted by the Gaming Act (Variation of Monetary Limits and Fees) Order 1975(c)), there were substituted references to the sums specified in the fourth column thereof, respectively.

4. In the Schedule to the Gaming Act (Variation of Monetary Limits and Fees) Order 1975 the entries relating to section 48(3) and section 48(4) of the Gaming Act 1968 shall be omitted.
