1976 No. 604 (L. 8)**COUNTY COURTS****The County Court Districts (Staines) Order 1976***Made - - - - 13th April 1976**Coming into Operation 3rd May 1976*

The Lord Chancellor, in exercise of the powers conferred on him by section 2 of the County Courts Act 1959(a), hereby makes the following Order:—

1.—(1) This Order may be cited as the County Court Districts (Staines) Order 1976 and shall come into operation on 3rd May 1976.

(2) The Interpretation Act 1889(b) shall apply to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.

2. A county court shall be held at Staines under the name of the Staines County Court, and the new entry set out in Schedule 1 to this Order shall be inserted in Schedule 1 to the County Court Districts Order 1970(c), as amended(d), immediately after the entry relating to the Stafford County Court.

3. The amendments set out in columns 2 and 3 of Schedule 2 to this Order shall be made in the corresponding columns of Schedule 1 to the County Court Districts Order 1970 opposite the names of the courts mentioned in column 1.
