At the Court at Buckingham Palace, the 19th day of May 1976

Present,

The Queen's Most Excellent Majesty in Council

Her Majesty, in exercise of the powers conferred upon Her by sections 2, 17 and 21 of the Extradition Act 1870(a) and sections 5(2), 27(1) and (3) of the Protection of Aircraft Act 1973(b), or otherwise in Her Majesty vested, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows :—

**1.** This Order may be cited as the Extradition (Protection of Aircraft) (Amendment) Order 1976 and shall come into operation on 16th June 1976.

**2.** The Interpretation Act 1889(c) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

**3.** The Extradition (Protection of Aircraft) Order 1973(d), as amended(e), shall be further amended by adding to Schedule 2 (which names the foreign States with which the United Kingdom has extradition treaties in force and which are parties to the Convention for the Suppression of Unlawful Acts against the Safety of Civil Aviation signed at Montreal on 23 September 1971(f)) the following entry :—

The Extradition (Protection of Aircraft) Order 1973 shall be further amended by adding to Part I of Schedule 3 (which names the foreign States with which the United Kingdom has no extradition treaties in force and which are parties to the Convention for the Suppression of Unlawful Acts against the Safety of Civil Aviation signed at Montreal on 23 September 1971) the following entry:—
