COUNTY COURTS

The County Court Districts (Staines) (Amendment) Order 1976

Made - - - - 20th May 1976

Coming into Operation 15th June 1976

The Lord Chancellor, in exercise of the powers conferred on him by section 2 of the County Courts Act 1959(a), hereby makes the following Order:—

1.—(1) This Order may be cited as the County Court Districts (Staines) (Amendment) Order 1976 and shall come into operation on 15th June 1976.

(2) The Interpretation Act 1889(b) shall apply to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.

2. The County Court Districts (Staines) Order 1976(c), which amends the County Court Districts Order 1970(d), shall be amended by substituting for Schedules 1 and 2 thereto the following Schedules:—
