## PROCEDURE

**The Judicial Committee (Fees) Rules 1976***Made* - - - 9th June 1976*Coming into Operation* 1st July 1976

At the Court at Buckingham Palace, the 9th day of June 1976

Present,

The Queen's Most Excellent Majesty in Council

Whereas there was this day read at the Board a representation from the Judicial Committee of the Privy Council recommending that the Fees set out in Part II of Schedule B to the Judicial Committee Rules 1957(a) as amended by the Judicial Committee (Fees) Rules 1971(b) ought to be revoked and that the Fees set out in the Schedule thereunto annexed ought to be substituted therefor:

Now, therefore, Her Majesty, having taken the said representation into consideration, and in exercise of the powers conferred on Her by section 24 of the Judicial Committee Act 1833(c) or otherwise in Her vested, is pleased, by and with the advice of Her Privy Council, to approve thereof and to order, as it is hereby ordered, as follows:—

1. The Fees set out in Part II of Schedule B to the Judicial Committee Rules 1957 as amended are hereby revoked and the Fees set out in the Schedule annexed to the said representation are substituted therefor, as set out in the Schedule to these Rules.

2. These Rules may be cited as the Judicial Committee (Fees) Rules 1976 and shall come into operation on 1st July 1976.
