# The Social Security (Claims and Payments) (Unemployment Benefit Transitory Provisions) Regulations 1977

Made - - - 28th July 1977

Laid before Parliament 5th August, 1977

Coming into Operation 5th September 1977

The Secretary of State for Social Services, in exercise of the powers conferred upon him by section 79(1) and (3) of the Social Security Act 1975(a) and of all other powers enabling him in that behalf, after reference to the National

Citation, commencement and interpretation

1.—(1) These regulations, which may be cited as the Social Security (Claims and Payments) (Unemployment Benefit Transitory Provisions) Regulations 1977, shall come into operation on 5th September 1977.

Insurance Advisory Committee, hereby makes the following regulations:-

- (2) In these regulations—
  - (a) "spell of unemployment" means any period of one or more days on which a person is unemployed and any two or more such periods, not separated by a period of more than 3 consecutive days which in relation to that person are not days of unemployment, shall be treated as one spell of unemployment;
  - (b) "unemployment benefit office" means any office or place appointed by the Secretary of State for the purpose of claiming unemployment benefit.
  - (c) in computing any period of time Sundays shall not be disregarded.
- (3) The rules for the construction of Acts of Parliament contained in the Interpretation Act 1889(b) shall apply for the purposes of the interpretation of these regulations as they apply for the purposes of the interpretation of an Act of Parliament.

Limited transitory provision for claims for unemployment benefit in advance

2.—(1) The provisions of this regulation shall apply for the purposes of a claim for unemployment benefit, made within a period of one year commencing with the coming into operation of this regulation at an unemployment benefit office specified in the Schedule to these regulations, where that claim is made by a person who has, during the spell of unemployment in which such claim is made, already made a claim for unemployment benefit at that unemployment benefit office.

- (2) A claim for unemployment benefit to which this regulation applies may, unless in any case the Secretary of State otherwise directs, be made, on the form approved by the Secretary of State for the purpose, for a period falling in part before the date of the claim and in part, by not more than 7 days, after the date of the claim and, on any such claim, benefit may be awarded for the period to which the claim relates.
- (3) Any decision under paragraph (2) of this regulation awarding unemployment benefit in respect of any period falling after the date of the claim shall be subject to the condition that the claimant continues to satisfy the requirements for payment thereof during the period to which the award relates and, if the said requirements are found not to have been satisfied at some time during the said period, the award shall be reviewed.

### **EXPLANATORY NOTE**
