**The Fishing Boats (Specified Countries) Designation (No. 3)
(Variation) Order 1977**

<i>Made - - - -</i>	28th July 1977
<i>Laid before Parliament</i>	29th July 1977
<i>Coming into Operation</i>	30th July 1977

The Minister of Agriculture, Fisheries and Food and the Secretaries of State concerned with sea fishing in Scotland and Northern Ireland respectively, in exercise of the powers conferred on them by sections 2(1) and 6(2) of the Fishery Limits Act 1976(a) and of all other powers enabling them in that behalf, hereby make the following order:—

Citation and commencement

1. This order may be cited as the Fishing Boats (Specified Countries) Designation (No. 3) (Variation) Order 1977 and shall come into operation on 30th July 1977.

Interpretation

2. The Interpretation Act 1889(b) shall apply to the interpretation of this order as it applies to the interpretation of an Act of Parliament.

Variation of principal order

3. The Fishing Boats (Specified Countries) Designation (No. 3) Order 1977(c) shall be varied as follows:—

(i) For article 4 there shall be substituted the following article—

“4.—(1) The Faroe Islands and Norway are hereby designated for the purposes of section 2(1) of the Act.

(2) In relation to the Faroe Islands and Norway there is hereby designated the area within British fishery limits other than that part of that area which is within 12 miles from the baselines from which the breadth of the territorial sea is measured.

(3) The descriptions of sea fish for which the fishing boats registered in Norway may fish in the area referred to in paragraph (2) of this article shall be all descriptions of sea fish.

(4) The descriptions of sea fish for which the fishing boats registered in the Faroe Islands may fish in the area referred to in paragraph (2) of this article shall be all descriptions of sea fish except herring.”

(ii) For article 5 there shall be substituted the following article:—

“5. The provisions of this order so far as they relate to the Faroe Islands shall cease to have effect on 15th September 1977.”

EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order varies the Fishing Boats (Specified Countries) Designation (No. 3) Order 1977 (the principal order) as follows:—

1. Herring are excluded from the descriptions of sea fish for which fishing boats registered in the Faroe Islands may fish.
2. The time during which the provisions of the principal order (as varied by this order) relating to the Faroe Islands are to have effect is extended until 15th September 1977.
