**The Sea Fishing (Specified Foreign Boats) Licensing (No. 3)  
(Variation) (No. 3) Order 1977**

The Minister of Agriculture, Fisheries and Food and the Secretaries of State respectively concerned with the sea fishing industry in Scotland and Northern Ireland, in exercise of the powers conferred on them by sections 4 and 20(1) of the Sea Fish (Conservation) Act 1967(a) as the former section is amended by section 3 of the Fishery Limits Act 1976(b) and of all other powers enabling them in that behalf, hereby make the following order:—

*Citation and commencement*

1. This order may be cited as the Sea Fishing (Specified Foreign Boats) Licensing (No. 3) (Variation) (No. 3) Order 1977 and shall come into operation on 16th December 1977.

*Interpretation*

2.—(1) In this order “principal order” means the Sea Fishing (Specified Foreign Boats) Licensing (No. 3) Order 1977(c) as amended(d).

(2) The Interpretation Act 1889(e) shall apply to the interpretation of this order as it applies to the interpretation of an Act of Parliament.

*Variation of principal order*

3. For Schedule 2 to the principal order there shall be substituted the following schedule—
