Act of Adjournal (Fees in the High Court of Justiciary) (Amendment) 1977

Made - - - 14th January 1977

Coming into Operation

7th February 1977

The Lord Justice-General, the Lord Justice-Clerk and the Lords Commissioners of Justiciary, under and by virtue of the powers conferred upon them by section 2 of the Courts of Law Fees (Scotland) Act 1895(a) and of all other powers competent to them in that behalf, do hereby, with the approval of the Treasury, enact and declare:—

Citation, commencement and interpretation

- 1.—(1) This Act of Adjournal may be cited as the Act of Adjournal (Fees in the High Court of Justiciary) (Amendment) 1977 and shall come into operation on 7th February 1977.
- (2) The Interpretation Act 1889(b) shall apply to the interpretation of this Act of Adjournal as it applies to the interpretation of an Act of Parliament.

Amendment of High Court Fees

2. In the Act of Adjournal (Fees in the High Court of Justiciary) 1970(c), for the table of fees in the Schedule there is substituted the table of fees set out in the Schedule to this Act of Adjournal, and the fees so substituted shall be payable in respect of the matters to which they relate from the date this Act of Adjournal comes into operation.

Revocation

3. The Act of Adjournal (Fees in the High Court of Justiciary) (Amendment) 1975(d) is revoked.

And the Lords appoint this Act of Adjournal to be recorded in the Books of Adjournal.
